RELEASE OF MARK NIKLUS FROM SOVIET PRISON CAMP

Mr. Bill Attewell (Don Valley East): Mr. Speaker, I have the honour to present a petition signed by over 1,500 concerned Canadians. They are calling for the release of Mr. Mart Niklus, a prisoner in the Soviet Chistopol prison camp. He was sentenced to 10 years hard labour and five years internal exile. Mark Niklus' only crime was to speak out against the Molotov-Ribbentrop—

Mr. Attewell: These concerned Canadians, Mr. Speaker, are calling on the Houses of Parliament to urge the Soviets for his release.

## CHANGES TO OLD AGE SECURITY ACT

Mr. Don Boudria (Glengarry-Prescott-Russell): Mr. Speaker, I have a petition signed by 38 people of St. Isidore de Prescott, Ontario. These people are objecting to the discriminatory provisions of Bill C-26 which would discriminate against single, unmarried and divorced people between the ages of 60 and 64.

I have another petition signed by Members of the Golden Age Club, Hawkesbury, Ontario, signed by 35 people. They object to the discriminatory provisions of Bill C-26, which would adversely affect single, divorced or separated people between the ages of 60 and 64—

—and it is signed by three residents of the village of Plantagenet who are against the discriminatory provisions of Bill C-26 under which needy persons living alone, as well as single and divorced persons aged 60 to 64 would be denied benefits.

Mr. Speaker, I have a petition signed by 150 people who are members of the Unions culturelle des franco-Ontariens and who are opposed to the provisions of Bill C-26 which discriminates against needy single, divorced or separated persons aged 60 to 64.

Mr. Speaker, I have a petition signed by three residents of the village of Limoges, Ontario, who are also opposed to the provisions of Bill C-26 which might discriminate against needy single, divorced or separated persons aged 60 to 64.

I have another petition, Mr. Speaker, and this one is signed by six residents of Rockland's Laurier House. As you may have guessed, Mr. Speaker, these people are against Bill C-26 discriminatory provisions which would prevent needy persons aged 60 to 64 who live alone, and single, divorced or separated people persons from receiving benefits to which they are entitled.
