HEALTH

Mr. Stan Wilbee (Delta): Mr. Speaker, my question today is for the Minister of National Health and Welfare. There are over 200 people in the Upper Fraser Valley who have been diagnosed with an illness that has been termed the enviro disease or somatically, chemically induced dysfunction syndrome.

As pointed out by my colleague from Fraser Valley East on Friday, this is a matter of urgent concern to the residents of that area. With allegations of chemicals leaking into the aquifer in the Fraser Valley and a clustering of cases in that area, can the Minister of National Health and Welfare inform the House of the actions that he and his department have undertaken to address this serious problem.

Hon. Benoît Bouchard (Minister of National Health and Welfare): Mr. Speaker, I have to say first that the officials of the Department of National Health and Welfare have been in touch with the local and provincial health officials since early 1990. After a thorough investigation undertaken by the department, we could not conclude that there was any evidence to show that there was an increase of muscle weakness in the Abbotsford population. However, we are continuing to work with the province and we are prepared to offer all the assistance we can to the province of British Columbia to investigate the issue and determine whether there is any other finding that we have not made so far.
