

FIELD GENERAL COURT-MARTIAL

(Whether the accused to be tried is under his comd or not. a FGCM may an application to him be convened by any offr of Cdn Army Overseas, or dany other force if authorized in law, in immediate comd of trarps on active service, subject to RP 103(C) and restrictions imposed by appropriate authy. A 49, 50, RP 104-107, 114. As to the duties and privileges of the Canvening Offr in dealing with the application see MML Chap V paras 20 and 23, TRP 87(E).

There should be a separate Convening Order for each person to be tried separately by the same Court. RP 71(C), 109. As to separate charge sheets see RP 108. As to two or more accused charged jointly see RP 16, 109.
