KINGS COUNTY COUNCILLORS TAKE ANOTHER RAP AT PROVINCIAL HEALTH ACT

Council Votes \$1,000 Toward Cost of Monument to be Erected at Hampton in Memory of Kings County Boys Who Fell in the World War—Estimates Passed.

Hampton, Jan. 25.—The Kings County Municipal Council took another crack at the Provincial Health Act to day, and dismissed its former appointees to the Board of Health and appointed, in their place, three members of the Council who were instructed to curb the desire of the board to spend money. Dr. Gilchrist was present at the morning session and paid his respects to the members of the Council who had made charges of extravagance in connection with the building of the municipal hospital.

It was decided to memorialize the Government to repeal the dog tax, so far as the county of Kings was concerned, and to assess the sum of \$1,000 toward the cost of a monument to be erected to the 10th Battalion, and other fallen heroes of Kings County, the same to be erected at Hampton. Estimates, to the amount of \$31,000 were passed. The draft bill to amend the present rates and taxes on dogs was approved, but the draft of a bill to provide a superannuation fund for municipal officials did not meet with the favor of the councillors.

The wardens, Councilor Guilford and the County Secretary were appointed delegates to the 1932 meeting of the Union of New Brunswick Municipalities. A proposition to make the assessment for the care of pauper patients in the Provincial Hospital apply to the general county assessment, instead of the special assessment which the patient makes, was defeated.

Warden Gorham occupied the chair and all the councillors were in their places at both sessions today.

Morning Session
The council was called to order by the warden at ten o'clock.

The first business was a resolution, moved by Councilor Walton and seconded by Councilor Sear, that, in the opinion of the Council, it would be advisable to have the law requiring a tax on dogs repealed.

Councilor McAuley, in supporting the motion, said the reason why farmers had gone out of the sheep business was not because of the dogs, but because they did not fence property.

Councilor McKenna said Councilor McAuley had indicated there was something improper in Mr. Glendinning getting the work, and that Mr. King had used his influence to that end and that Dr. Gilchrist had been switched from one purpose to another.

Councilor McKenna charged that Councilor McKenna was putting words in his mouth which he had not said. At this stage the warden declared the debate out of order.

Councilor McKenna moved, seconded by Councilor Armstrong, that the officials of the General Public Hospital, St. John, be requested to be more prompt in notifying the County Secretary when patients were taken into the institution, whose keep was chargeable to Kings County, and to forward full particulars, particularly the parish from which the patient came, Canada.

Bills to the amount of \$1,247.65 passed at the July meeting of the Finance Committee were approved by the Council.

Afternoon Session
When the afternoon session opened, Councilor Sprout asked permission to refer to the much talked of Health Act, and the powers of the Board of Health, which, he thought, were misconstrued by a great many people, and this was the confused allusion to the lay mind. He then read from the judgment of His Honor, Judge Barry, who, in that judgment, made the statement that it was a mistake to say the municipality had no say in the amount of money which the Board of Health could ask for, inasmuch as they appointed a majority of the members of the Board. This was pointed out by the original act which provides that if the Board was composed of three members, the municipal council should appoint two, or if of five, they should appoint three, but the amendment of 1910, the Government enacted that the district Medical Health Officer should also be a member of the Board and this made the Government and Municipal appointees even.

The present Municipal appointees, Messrs. O. W. Wetmore, M. L. A. G. and, therefore, could not keep their sheep at home.

The motion carried, eighteen voting in favor and twelve against it.

Councilor McKenna moved that Dr. Gilchrist who was chairman of the committee which interviewed the Government with regard to having the terms of Councilors changed from two to four years, be heard in connection with their mission. Dr. Gilchrist reported that the committee had seen the Government in regard to enacting this legislation, but, as it applied only to the county of Kings, they would not bring it as a Government measure, but would pass it as a private measure. H. Viewelling and A. D. Murray, had, in his opinion, been remiss in their duties in that they had failed to keep in touch with the Council, and failed to regard their wishes in the matter of money, expressed by their action in refusing to assess for more than half of the amount the first year, and in voting nothing at all last year, and he moved they be removed from office forthwith. His motion was seconded by Councilor McAuley and passed unanimously.

Councilor Sear moved, seconded by Councilor Hayes, that the sum of \$1,000 be voted for the purpose of erecting a monument to the fallen heroes of the 10th Battalion and other men from Kings County who had laid down their lives in the great war, this being one-fourth of the cost, the other three-fourths to be borne by Senator Fowler and the 10th funds. The motion carried unanimously.

On motion of Councilor Gilbert, the division of the assessment on the Parish of Rothesay, between the village and the rest of the parish, was made on the basis of \$100 on the village and \$50 on the parish.

Councilor Sear moved the appointment of Councilors M. L. Sprout, J. E. McAuley and Elias Keith, to the sub-district Board of Health for Kings.

Assessments Ordered
The assessments ordered were: treatment of patients in hospital, \$4,000; county school fund, \$12,500; contingent, \$8,000; patriotic fund interest, \$1,000; sinking fund, \$1,000; pauper lunatics, \$3,200; and the latter by parish was: Cardwell, \$628.10; Greenwell, \$467.50; Hammond, \$1,075.50; Hampton, \$1,016; Havelock, \$1,075.50; Kings, \$1,075.50; Springfield, \$95.70; St. John, \$1,177.50; Sussex, \$582.50; Upham, \$1,075.50; Waterford, \$215; Westfield, \$1,075.50.

On motion it was decided to hold any semi-annual session this year. The Meadows Committee reported as follows: Sale of hay on Grassland Island, \$1,075; Pig Island, \$40; a total of \$1,115; expenditure of \$43; leaving a net balance of \$1,072, and recommended that C. H. Gorham be the collector for Grassland Island for 1922, and that the committee be authorized to build or buy a scow for the eastern side of the river. The report was received and the recommendations ordered carried out.

The warden read a letter from Robert Crawford offering for the sum of \$150 per month, to provide special police protection for the summer cottages in the parishes of Rothesay and Westfield, two men being on the job all the time, and stated he had been asked to take this step by a large number of the taxpayers of this district.

Councilor Gilbert thought this should be a charge on the two parishes which got the benefit, not on the whole county, and said he thought Rothesay would be willing to pay its share. Councilor Langley thought the Parish of Westfield would not get the worth of its money from only two men to cover such a large beat. Councilor McAuley moved the committee be asked to lay on the table for twelve months, and this carried.

The committee which interviewed the Government in regard to the fees charged by the St. John Hospital, reported that they had been informed this matter was in the hands of the Hospital Commissioners, and the Government had no jurisdiction. Report received.

On motion, the draft bill prepared by a committee from the Union of New Brunswick Municipalities to amend the present Rates and Taxes Act was approved by the Council.

The draft of a bill to provide for a superannuation of municipal employees was not approved.

The report of the committee who administered the relief fund for the Westfield fire sufferers, was received and ordered printed in the minutes. This committee spent \$588.37 for shingles and the balance of \$4,000 was distributed in cash.

The rate of pay for the collector of the Parish of Rothesay was fixed at six per cent, instead of the usual five per cent.

The sum of \$84 was assessed on the Parish of Hampton for road damage.

Warden Gorham, Councilor Guilford and County Secretary City were appointed delegates to the 1932 meeting of the Union of New Brunswick Municipalities.

A large number of bills approved by the finance committee were passed for payment.

Councilor Smith moved, seconded by Councilor Langley, that legislation be brought to provide that the assessment for the maintenance of pauper patients at the Provincial Hospital be made on the county at large instead of on the parishes as at present. Carried.

The finance committee reported that four bills for constables appointed to watch property after the Westfield fire, had been out paid from \$17.50 each to the constables and the recommended this amount be paid and charged to the Parish of Westfield; and refused payment of three bills. Adopted.

By this time the councillors had overlooked to the effect of the motion.
