LONDON, May 3. Great victories reported by Don Carlos' forces under the command of Saballo over the Spanish Government troops at Breda Le Vida and Santo Coloma. The latter place is in the Province of Barcelona. The enemy numbered 4,000. They lost five chief officers in the first engagement, and 150 men in that of Santo Coloma. Another great victory for Carlism under Castillo is reported from Aragon. The Government troops are said to have lost all their artillery and many prisoners. The Alfozeta General DeLatre was killed.

A telegraph despatch from Berlin says that the last Belgian note is considered highly satisfactory and terminates the controversy.

It is reported that Russia has with great earnestness urged England to send delegates to the International Code Conference at St. Petersburg. If England persists in her refusal it is probable the whole project will be dropped in accordance with the advice of the other powers.
