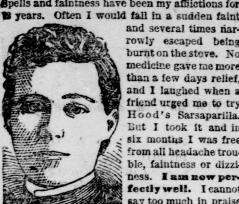

THE PREMIER SPEAKS.
Premier Bowell expressed regret at the tone of the latter portion of Mr. Angers' speech. He resented it. On all matters of grave importance there must be differences of opinion between thirteen or fourteen gentiemen. He denied Mr. Angers' insinuation that his course was influenced from outside. He had himself suggested the announcement on Moneay in order to bring together all the elements of the Cabinet, in order to grant, when the time arrives, these rights of which he had always said they had been despoiled. He was not in favor of separate schools per se, but there was a promise made when Manitoba came in that separate schools should be maintained forever, and he felt bound-and he would take his party as far as he could—to carry out the promises. He hesitated to pass remedial legislation because he reflected upon the great danger to Provincial autonomy and to the peace of the Dominion. He quoted Mr. Tarte in proof of the opinion that it was impossible to coerce Manitoba, and in order to show that the Liberals were opposed to remedial legislation. Referring to Mr. O'Donohue's remark, Sir Mackenzie Bowell said: "If my Upper Canada colleagues retire from fear-a quality they do not possess-I shall try to fill their places with gentlemen who hold my views. The hon-crable gentleman had said that if they submit to remedial legislation they would not be re-elected to Parliament. If that be the case, and probably it is, so much greater is the credit to be their political lives in their hands." He was sorry that Mr. Angers had no confidence in the pledges of the Government. These pledges would be carried out if life lasted and the Government were enabled to do it by majorities in Parliament. Was it not better, however, to have these concessions made by Mani-toba than by the Dominion, in order to have the religion of the parents taught to the children. He did not agree with the Manitoba Government that the remedial order required the

petitions of the Roman Catholics, there was no pledge in the order that these were to be carried out to the letter. He would not argue whether the Manitoba schools prior to 1890 were efficient or not. Mr. Bernier had answered that question very well some time ago. The minority were willing to have certificated teachers, a proper inspection, and that the public money should be expended under inspection. While the Government had placed within the power of Parliament the authority to go the full length of the demands, there were the state of the demands, there was nothing in the remedial order to prevent them adopting a medium course provided it met with the ap-roval of the people demanding it. He took it that all the Catholics required was the right to have separate schools, to be relieved of taxation for public schools, to be enabled and to have power and authority to teach morals and religion as they understood it, and to have the full management of their schools, and that far the Government of which he was the head was prepared to go, if Parliament would sustain them, if they did not get a fair measure of relief from Manitoba. The Premier then argued that Manitoba had held out promises of that kind. In support of this he quoted the clause in the answer of Manitoba promising to cheerfully furnish all information necessary for a full and deliberate investigation of the whole subject. He should object to a commission as ut-terly useless, but he would approach the Legislature of Manitoba with the proposition, "Are you prepared to restore separate schools under such a system as to insure efficiency, with proper inspection and relief from taxation, for other schools?" He said that he was not defending the Government of Manitoba, which had so far refused to do

anything in this direction. Mr. Bernier-Do you expect them to do otherwise now? Sir Mackenzie Bowell-I cannot say that I do, but I do not propose to put myself in the position to have the leaders of the Opposition or the Province from which I come (where a large majority hold different views) to say to me and the Government, "You forced upon these people a system of education without first accepting their half-measure of promise of conciliation." I do not express any confidence I do not hope, but I cannot say that it will be fulfilled. I wish to be able to say that we have exhausted every means before I am prepared to force upon them a system which may prove detrimental to the country, and to the peace and harmony of the Dominion. If it is done by the Dominion Parliament I fear that every obstacle will be thrown in the way, and law suits will arise, and it will become a bone of contention for years to come, and instead of five years of litigation you will have a much longer period. The Premier then read a letter from a person whom he described as a judge in Western Ontario, a Protestant, in order to show that Ontario was not opposed to his policy. After stating that every one had an admiration for the Government, the judge went on to say: "We were never so proud of our party in

determining not to interfere with Manitoba so long as there is a chance that she can be got to do what is right, and in determining to make her do so if she will not voluntarily do it herself. It is a statemanlike course." The Premier added: "While he speaks for the Conservative party he echoes the opinion of many Liberals in my Province." Sir Mackenzie Bowell warned the extremists of both parties to const grave responsibilities that this Parliament took when it enacted a measure that it would be compelled in the future to put in force and fight the Provincial Government upon in order to enforce if and give it he slightest effect. He closed with the quotation from a favorite Methodist hymn: "While the lamp holds out to burn the vilest sinner may return."

NEARLY A MILLION FOR A JOKE.

The Price of a Railroad Advanced That Much by a Dude's Bid.

Cincinnati Commercial Gazette. Samuel P. Schuckers died recently at Wooster, O. He was a brother of J. W. Schuckers, private secretary of Salmon P. Chase, and brother-in-law of John H. Oberly, ex-civil service commissioner. An interesting incident is recalled by Schuckers' death which has never found its way into the newspapers. The incident occurred a number of years ago, and during the time of the sale of the Lake Shore Railroad at Cleveland it happened that Schuckers and John McSweeney, the great criminal lawyer, met at the sale. Mc-Sweeney had but a short time before made a great hit by his political speeches at Cleveland and Philadelphia, and was attracting attention all over the country. At this particular time he was trying a case at Cleveland. Young Schuckers was in these days a veritable dude and very sprucy.

He went to Cleveland to have a time, as he always left Wooster to celebrate, and was having a good, glorious time on this particular occasion. He was small and wiry in stature, and always carried a silk umbrella. It happened that he met McSweeney in the rotunda just as he had finished an argument, and while the sale of the Lake Shore Railroad was going on. They stopped for a moment at the edge of the excited crowd bidding in the road. There were a number of syndicates represented-foreign, Vanderbilts, Goulds and others. The bidding had reached \$3,100,000. In a spirit of devilishness young Schuckers bid \$3,500,000. In a moment a rush was made toward the new bidder and a demand was made to know what syndicate he represented. His only reply was, with a wave of his silk umbrella, "Go away from me." The excited representatives of the other syndicates asked for a recess, which was granted, and in twenty minutes they came back, when the bid was raised to \$4,000,000 and sold.
