STREET RAILWAY APPEALS TO PRIVY COUNCIL

Trustees Demand Ban On Use of Schools For Propaganda

COMPANY SOON TO INVOKE HIGHEST COURT IN EMPIRE IN TROLLEY FARES CASE

His Majesty's Privy Council Will Have Next Say on the Question of Whether Londoners Shall Pay Five Cents or Not For Ride on Cars, R. G. Ivey Announces.

NO ORDER AFFECTING RATE IN MEANTIME

London's street railway problem is to be carried to the privy council in England for a final decision, according to an announcement by R. G. Ivey, vice-president of the London Street Railway Company, this morning.

"We have decided to appeal the decision of the appellate court," said Mr. Ivey, "which will mean that the case will go to the privy council in England."

Mr. Ivey pointed out that under the statutes this is the only course open, since the act governing the operation of the Ontario railway and municipal board distinctly states that when an appeal relates to the construction of an agreement between a railway company and a municipality, "the appeal shall lie from the divisional court of the appellate division of the supreme court, to his majesty in his privy council."

Thus the highest court in the British empire will be asked to decide whether Londoners shall pay a five-cent fare for a street car ride or whether they shall ride for seven and nine tickets for a quarter.

In the meantime, according to the road's vice-president, the company will maintain the best service possible on a five-cent fare. "It is needless for me to say that we're not making money at the present time," Mr. Ivey added, "but it is impossible for us to operate at seven and nine tickets for a quarter."

While the appeal to the Privy Council is pending, the whole question of fares in London presents several interesting angles.

The appellate court in the British law, has said that the company must revert to the old rate of fares. But no order has been made either direct or through the Ontario Railway and Municipal board to compel the company to take such action. Presumably the company's notice of its intention to appeal the decision will automatically suspend any action to put the finding into effect. If this is true, there is nothing more to be done but to await the decision of the Privy Council.

BELGIUM FEARS DUMPING IN GERMAN COAL TRADE

Brussels, Belgium, Nov. 10.—Because Belgian consumers can obtain coal direct from the German producers at a price cheaper than that costs the German government, Belgium fears that the German government will bring reparations payable to Belgium to the government has decided to suspend further shipments under the Dawes plan pending measures to prevent dumping.

According to the newspapers 30,000 tons have already been rejected for which under the existing arrangement Germany must be paid one gold mark per ton. Negotiations regarding the matter are reported to have been opened between Brussels and Berlin.

Toronto Couple Tell Court of Previous Visit to Infants' Home—Case Adjourned.

GIRL BREAKS DOWN

Case Will Be Probed to the Limit, Judge Declares Before Parents.

NOTICE IS POSTED FOR NOMINATIONS

One Nomination Meeting For Aldermen Instead of Four This Year.

SYSTEM IS SIMPLER

Dr. H. A. Stevenson Mentioned as Possible Aspirant For the Mayoralty.

Public notice regarding the nomination of candidates for the coming municipal election on December 7 was posted this morning at the city hall.

The fact is a reminder that nomination day is only 13 days distant. A public meeting for the nomination of candidates for mayor, public utilities commissioners and hospital trustees will be held at the city hall from 10 to 11 a.m. on November 23. Nominations for members of the board of education will be received between the hours of 12 noon and 1 p.m. on the same day, while nominations for aldermen cannot be made until the evening between the hours of 7:30 to 8:30. All nominations must be made in writing.

Procedure is simplified to some extent this year by the fact that aldermen are to be elected from the city at large so that it will only be necessary to hold one nomination meeting instead of one in each ward as formerly.

Voting December 7.
Voting will take place on December 7, the polls being open continuously from 8 a.m. to 7 p.m. The advance poll for railwaymen, commercial travellers and others whose occupations make it impossible for them to vote on election day will be held on Thursday, December 3 and also Friday and Saturday the 4th and 5th, from 9 a.m. to 6 p.m.

With Mayor Wenig already definitely in the field for a fourth term, a contest for the mayoralty looms with the nomination of Dr. H. A. Stevenson, a former mayor of the city for three consecutive terms, would again allow his name to be placed in nomination. The advertiser was unable to reach Dr. Stevenson up to press time, but should he decide to allow his name to stand, a decidedly interesting contest would result. Names of J. A. E. Braden and James Granger are also mentioned as possibilities for the mayoralty contest, but friends of both state that neither is likely to stand, although Mr. Braden may become an aldermanic candidate.

Contests for Aldermen.
In the latter field there seems every possibility of interesting contests for the eight positions to be filled.

Members of last year's council definitely in the running so far are Ald. Carwell, Ald. Ashton, Ald. Dalg and Ald. Edwin Smith. In addition to these, John A. Croden has announced himself a candidate and ex-Ald. Dr. Drake has publicly stated his intention of running on a wet platform. This injects a new issue into municipal politics, where up to now temperance has never been an issue. It may have the effect of decidedly increasing the number of votes cast on election day.

A moral issue is sure to bring out a strong vote of members of the men's brotherhoods in the various churches of the city.

ITALY IS ROUSED OVER JUGO-SLAVS

Government Demands Satisfaction For Sunday's Anti-Italian Demonstrations.

ROME IS GRIEVED

Jugo-Slavians Revenge Alleged Fascist Excesses—Flags Burned.

Rome, Nov. 10.—The Italian government has asked "satisfactory satisfaction" from the Jugo-Slavian government for Sunday's anti-Italian demonstrations and the defiling of Italian flags in various cities of the Jugo-Slav state. Announcement to this effect was made today in an official communique.

The newspapers, especially the Fascist Popolo di Roma and Il Tevere, express regret that incidents should arise to disturb the atmosphere of tranquillity between the two peoples brought about by the treaties signed in July at Nettuno by Premier Mussolini and the Jugo-Slavian minister.

They point out that Rome has been playing the part of a gracious host to the Jugo-Slav football team, which is scheduled to play the Rome team tomorrow, and also refer to the enthusiastic address delivered by General Veltchinsky, the Jugo-Slav military attaché, at the dinner in honor of Commander Di Pinedo, Italy's longest distance flying ace.

Precautionary Measures.

SCHOOLS NOT FOR ADVERTISING FADS, TRUSTEES ASSERT

Commercialism of London Public Schools To Come Under Ban If Committee Has Way.

RESOLUTION PASSES

Temperance Lectures, Distribution of Blotters, Pamphlets, All Come Under Ban.

Commercialization of London schools is to be strictly under the ban in future if the board of education approves of a recommendation passed by the executive committee of the board this morning.

Requests from the G. W. V. A. for 50 girls for poppy day, and from the anti-cigarette league for permission to give lectures to teen age boys in the school regarding the poisonous effects of tobacco, were denied by the committee, and the resolution adopted.

Trustees Mrs. J. I. A. Hunt, was unanimously adopted by the committee.

"We have just started school," observed Mrs. Hunt, "but already the Western Fair, the L. O. D. E. and the Kiwanis club have wanted to commercialize the schools. I am not in favor of throwing open the schools so that the public can go and have their fads strung over our children. Our schools, I think, should be kept as schools, and nothing else. I would like to move that a resolution be passed to the effect that no person, other than the pupils and the schools, so that, when anything like this does come up we will be able to dispose of it at once."

Many Would Lecture.
Other members of the committee referred to the fact that there have been requests in the past to give temperance lectures in the schools, to distribute blotters with different kinds of advertisements, to distribute pamphlets advocating health insurance and other similar schemes to secure free advertising or make free use of the pupils of the schools.

Administrator G. A. Wreble expressed the opinion that the resolution by the anti-cigarette league are "purely educational with chemical demonstrations of the poisonous effects of tobacco on the human body. From 10 to 25 lectures, it was stated, would be given for a fee of \$25, which would be paid, not by the board but by private subscription."

It was finally decided to recommend to the board that though the schools should not be commercialized by having the lectures given during school hours, that the league be given the free use of two or three school auditoriums after school hours, and that the attendance of the pupils be entirely voluntary.

Assistants Approved.
The committee approved of the recommendations made by Dr. E. W. Fuller, chief dental officer, for lady assistants at the dental clinics, at the rate of \$100 for three and one-half hours each morning as follows: Miss Gladys Elliott, 81 Ridgeway street; Miss E. A. Miller, 290 Cromwell street, Riverview school; Miss Doris Massey, 16 Marley place, Lorne school; Miss Jean Meek, 294 Wolfe street, Trafalgar school. It was stated in answer to a question as to the age of the girls that "they are all over 32 and beyond the flapper stage."

The committee decided to recommend to the board that Roy E. Dewar and Miss Freeland be appointed as teachers of the two new adolescent auxiliary classes being organized at Alexandra school and that the two teachers be allowed railroad transportation to go to Toronto to visit similar classes there.

A communication from the London trades and labor council asked that the council be notified of the board's next meeting in order that a deputa-tion might wait on the board relative to a "fair wage resolution" which the trades and labor council had adopted. The secretary was instructed to inform the council of the regular board meeting on Thursday afternoon of this week.

New York, Nov. 10.—One of the most severe earthquakes of the year was recorded today on the seismograph at Fordham university. The exact distance of the disturbance could not be given, but experts of the university said it centered more than 5000 miles from New York.

The first tremors were recorded at 9:25 a.m., the maximum disturbance was reached at 10:05 o'clock, continuing at its height for twenty minutes. The shock lasted for more than an hour, being still in progress when the seismograph record was removed.

If he fell, I said, it would constitute a beautiful death; if he was wounded, national sentiment would have reverted in his favor."

General Groener added that his advice was not heeded. He further said that Ludendorff told him on September 25, 1918, that peace must be signed by Christmas of that year as the German army could not hold out any longer.
