## INTERIOR DEPARTMENT—POSITIONS ABOLISHED

Mr. MURPHY:

Justice to prosecute those known to have made counterfeit money and who have not yet been arrested; if not, why?

Mr. GUTHRIE:

1. Yes.

2. Two cases since January 1, 1935:

(i) Henri Martin sentenced on two charges: (a) making counterfeit coins; (b) uttering counterfeit coins.

Sentenced to three years' imprisonment on each charge to run concurrently.

(ii) Mrs. Henri Martin (wife of above) sentenced on one charge: uttering counterfeit coins.

Sentenced to four months' imprisonment.

3. The Royal Canadian Mounted Police have arrested all those known to have made and passed counterfeit money in circulation in the city of Quebec, except certain minors who were implicated.

4. It is not proposed to arrest and prosecute the minors referred to above, as it is considered they were largely influenced and lead into wrong doing by those already sentenced.
