MONTREAL POSTAL DISPUTE—MEASURES TO PROTECT PERSONS AND PROPERTY

Mr. Réal Caouette (Témiscamingue): Mr. Speaker, I have a question for the Postmaster General and Minister of Communications.

Following the acts of vandalism carried out as recently as last night in Montreal against mail trucks, new truck drivers and the public, is the department now taking any action to ensure the protection of the public and of property.

Hon. Eric W. Kierans (Postmaster General and Minister of Communications): Mr. Speaker, we are in continuing contact with the Montreal police and department officials are investigating this situation which I deplore, as do also all hon. members of this House. We definitely intend to take action against all the guilty parties.

POSSIBLE NATIONAL STRIKE—DELIVERY OF SOCIAL SECURITY CHEQUES

WHEAT—ACREAGE REDUCTION PROGRAM— QUOTA PRIVILEGES FOR SUNFLOWER-PLANTED LAND

Mr. George Muir (Lisgar): I have a question for the Minister of Agriculture. Since the production of sunflowers has proven to be an alternative to the production of wheat, thus providing a means for the reduction of wheat acreage, and also has the added advantage that it requires no public transportation or storage, will the minister consider adding land in this crop to those special crop lands eligible for quota privileges?

Hon. H. A. Olson (Minister of Agriculture): A great deal of thought has been given to that question and the decision, as the hon. member knows, is that we ought not to encourage diversion into crops where there is a possibility of overproducing with the result that the market is depressed. This is the reason oilseeds were not placed in the category mentioned.

Mr. Muir (Lisgar): Since there is no surplus in sunflowers, would the minister consider allowing this crop to be included in the special quotas for this year?

Mr. Olson: As I said, we have given consideration to that question.
