Until recently, Canada has had an enviable record of compassion for the underprivileged, especially refugees. CRIMINAL INJURIES COMPENSATION PLAN

Mr. John Brewin (Victoria): Mr. Speaker, I too have the honour to present a petition to the House of Commons. This one comes from people from across Canada, but primarily from my constituency in Victoria. It asks the House to enact a federal criminal injuries compensation plan. In particular, it endorses a bill which I have introduced for the House.

It was originally Bill C-310. It has now been reintroduced and I hope that the House will agree with the petitioners and enact the legislation.

DOMINICAN REPUBLIC

Mr. Stan J. Hovdebo (Saskatoon—Humboldt): Mr. Speaker, it is my honour and duty on behalf of 100 or so petitioners from the province of Quebec to call upon the Government of Canada and the United Nations to impose sanctions upon the Dominican Republic. The sanctions deal with the trade in human labourers between the Dominican Republic and Haiti.

JUSTICE

Mr. Bob Speller (Haldimand—Norfolk): Mr. Speaker, I rise again to present this House with a number of petitions on behalf of the family of Nina de Villiers. I have a number of petitions signed by people from throughout Haldimand—Norfolk. They call upon this government to bring amendments and to deal with tragic situations such as that, to amend the Criminal Code of Canada, the Bail Reform Act and the Parole Act accordingly.

I also understand on P-9 that someone from the department will be in touch with him regarding some of the information there. They will have a conversation which may be helpful to him and then help us in proceeding with the tabling of those documents.
