CC130 Hercules—12 at CFB Trenton and 12 at CFB Edmonton; CC115 Buffalo—5 at CFB Trenton. Load Capacities: CC130 Hercules—Normal 30,000 lbs for 2,500 miles, maximum 45,000 lbs for 1,500 miles; CC115 Buffalo—Normal 4,000 lbs for 1,400 miles, maximum 10,000 lbs for 300 miles.

Johnson make any mention of the international service of CBC and, if not (a) for what reason (b) is it considered unimportant and unworthy of comment (c) is Mr. Johnson aware that certain questions concerning the international service have remained unanswered on the *Order Paper* during the First and Second Sessions of the 30th Parliament, at least up until the date this question was asked and, if so, what are the reasons for such a situation?

Hon. John Roberts (Secretary of State): I am informed by the CBC as follows: 1. No. (a), (b) Radio Canada International is considered an extremely important component of the CBC, but by no means all the services and plans of the corporation were mentioned in "Touchstone for the CBC". It was designed as a blueprint for the domestic broadcasting services.

In so far as the Secretary of State is concerned: 1. (c) The government takes responsibility for the answers it provides to questions and for the process involved in replying to such questions. It is not appropriate therefore to provide information about internal administrative arrangements.
