

IRISH OFFICIALS TELL OF "WAR" ON BRITAIN

Sinn Fein Papers Describe Boycott of Royal Constabulary, Care for Wounded, Difficulties of Volunteers and Plan to Create Courts.

London, Aug. 12.—The five secret Sinn Fein documents considered at the June meeting of the Irish parliament in Dublin, which I am able to cable today, tell the story of Irish war on Great Britain, of the Irish boycott of the Royal Irish Constabulary, of methods used to care for the wounded and to guard their identity. They reveal the difficulties of the Irish volunteers, whose leaders, in increasing number, are being arrested by the British forces. They explain the Sinn Fein plan for establishing courts, both civil and criminal. It is exceedingly doubtful whether, from any other source, it would be possible to obtain such an accurate account of conditions in Ireland today as is afforded by these reports, written by Irish officials themselves, and which were never intended for publication. The documents, which I shall quote from verbatim, are in my possession in the form of photographic copies. The first four are short; the fifth, dealing with the courts, is important because it shows how extensive is the de facto government control of courts and what the attitude of the Irish public is toward these tribunals, which, in twenty-eight counties, today function under great odds, because their existence under British law is illegal.

Boycott of Royal Constabulary.

The first document reads: "General Headquarters, June 4, 1920. Boycott of Royal Irish Constabulary. Volunteers shall have no intercourse with the Royal Irish Constabulary and shall stimulate and support in every way the boycott of this force ordered by the Dail. Those persons who associate with the Royal Irish Constabulary shall be subjected to the same boycott, and the fact of their association with and toleration of this infamous force shall be kept public in every possible way. Details of such persons in the area of his command shall be prepared and retained by each company, battalion and brigade commander."

Medical Treatment of Wounded.

The second document follows: "June 8. Medical Treatment of Wounded. "First. It is very necessary that any volunteer wounded on volunteer work should receive immediate attention and be taken to the hands of a doctor of such discretion as well as national feeling that he shall not endanger the patient by indiscretion and shall assist in shielding him if possible. "Second. All volunteer officers should consider the doctors in their district from this point of view, and in any operations undertaken by them they should be quite clear that their minds as to the particular steps to be taken should any medical attendance be required. "In serious cases in which the local doctor states that the patient will require treatment at a Dublin hospital, particulars should be sent here as early as possible, stating the exact nature of the injuries and the date at which the patient could travel. It will usually be found necessary for a patient to spend a night or two in Dublin before being admitted to a hospital. A reference in assumed name from a local doctor will be required to the effect that the injured man is a patient of his. Generally, the brigade commander must arrange to bear the expenses."

Difficulties of Volunteers.

The third document runs as follows: "The Irish Volunteers' general Headquarters, Dublin Organization Department to the adjutant of the Eighth Cork brigade: "The chief of staff has transmitted to me your letter of the twentieth instant. I note that the vice commandant and other important officers of your brigade have been arrested before you could hold an election. Please consult the commandant and let me know what his opinion is in regard to the following questions: "First. Would you get suitable men to fill these vacant positions by holding elections or would you get better results by placing on the list men available and appointing them temporarily? "Second. If the commandant recommends the latter course, let me have the names of the men whom you would propose to appoint to the various positions. In the peculiar circumstances of your brigade, I would be prepared, if the commandant thinks it desirable, to recommend to the headquarters staff that vacancies should be filled by appointment rather than by elections."

Matters of Organization.

Document four reads: "Irish Volunteers General Headquarters, Dublin Organization Department to the adjutant of the Cork number eight brigade: "Thanks for your letter of the second instant. I quite understand the organization which has been caused by recent arrests and am glad to hear that you have matters well in hand again. I wrote to the adjutant a few days ago and asked him to send me your ideas as to how vacancies could best be filled. For the present, I think in any case where a number of battalion officers have been arrested, the best thing to do would be to carry on with the commandant and adjutant and not trouble about filling the two other posts until suitable men were readily available. Please let me have your views on this whole matter if your adjutant has not already forwarded them."

Report of Ministry on Courts.

The following is the fifth document: "Report of the Ministry on Home Affairs on Courts."

"The chief work has been in connection with courts of arbitration. Courts were set up in two counties almost immediately after the decree

of the Dail authorizing their establishment. The tribunals, though working under the greatest difficulties, held frequent sittings and their decisions gave general satisfaction. More recently Republican courts have been established or are authorized and are being set up in no less than twenty-eight counties. Orders of the courts have been obeyed as a general rule without hesitation. Public opinion is altogether behind the court decisions and there should be little difficulty in enforcing decrees even should any party against whom an order is made prove unwilling to obey. To give an idea as to the influence of the Republican movement on the public mind, I would instance the threatened land trouble in Kerry and Clare a couple of months ago. "This has not to do with the breaking up of ranches or demesne lands but with the claims which were put forward to small dairy and agricultural holdings by persons who stated that they or their ancestors had been wrongfully ejected. Most of the cases were of old date, and some were probably genuine grievances, for the most part, the claims were of the most unsubstantial character. These frivolous claims were being pressed forward at this particular moment because of the failure of the enemy's forces of law and order, and claimants hoped to take advantage of the absence of protection for property to assert demands which would never have been listened to in a court of law or of equity. Then, as regards those cases which were honestly brought forward by people who had lost their lands through the operation of England's unjust laws, they had been in abeyance so long that a few years' further delay, if it were necessary, would not prejudice them in any way.

"The main objection to allowing this class of agitation to develop was that it was certain to divert the attention of the people from the national struggle. Indeed, it looked as if the enemy had welcomed, if he had been at the bottom of this attempt to divide the people into factions, which would have been the result had the agitation been permitted to grow. If anybody hoped to create a state of chaos or anarchy, he was disappointed. The people's elected representatives on the Dail issued a manifesto stating that these land claims could not be entertained until after the recognition of the republic and until its government was firmly established and in full working order. The agitation was instantly quelled."

High Court of Appeal.

"The decisions of the parish courts under the schemes as outlined are subject to appeal to district courts whose ruling is final. Decisions of district courts are also subject to appeal, but so far no regular courts have been set up to rehear decisions. Cases of appeal from district courts have been discussed at a conference of members of the Dail and of the legal professions recently, and the following suggestion has been made: "That a panel of judges be selected, say six in number, and that four of these judges go on a circuit in the provinces at regular intervals three or four times yearly, and visit the chief towns in each province to dispose of appeals from the district courts. In this way it is hoped that the people would have justice brought to them cheaply and expeditiously. These judges would also form a supreme court of original jurisdiction, which could hear cases involving over \$500. They would also be a high court of appeal, that is to say, three of them could sit to hear appeals from decisions of any one of their number. A difficulty may be encountered in finding suitable men to act as members of the high court. None but men of experience and standing in the legal profession ought to be appointed. If such lawyers as these were prepared to take the risks attendant upon acceptance of office under the republic, the success of the arbitration courts would be assured."

Obstacles in Way.

"So far I have dealt only with courts of arbitration. In some parts of the country courts have, on their own initiative, undertaken work in excess of the power granted by the decree of the Dail. I refer, of course, first, to the ordinary work of courts of justice in which any party may sue another and compel his attendance to answer demand or complaint; second, to criminal cases. With regard to the first, I am anxious to see civil courts set up which would deal with work which has in the past been done in foreign courts in this country, but I see at least one great obstacle in the way, namely, want of machinery and power to enforce the decrees of the courts, especially where the defendants fail or refuse to attend or obey the decision, or attend and refuse to carry out the court's orders. In such cases it would be extremely difficult to compel payment of money awarded or to enforce the judges' rulings. In many parts of Ireland it would be utterly impossible in places where the British garrison is strongly represented or where the police arm is weak. I can see the failure of the courts in this respect, and such failure would go to stultify the show that the Republic is not the de facto government of the country. I think it my duty to point out such weaknesses, though at the same time
