The original paragraph of the Draft Address, after giving a summary statement of the finan-cial detail contained in the Speech, concluded thus : "These facts clearly indicate the pros-perity of the Colony, and we cannot be too thankful to Providence for the bountful harvests which have so largely contributed to that result?" Mr. Loscoworm, in submitting his amend-ment atributed the prosperity of the country to the general improvement of trade throughout all Her Majesty's dominions, to the late abund-ant crops, and the new markets opened up for our agricultural produce ; and, particularly, to the increased demand for shipping, which, he maid, has, at a rise in the prices of 100 percent, been nearly doubled since 1850.
