On motion of Mr. Mackenzie King, seconded by Mr. Fielding, it was ordered that the Address be engrossed and transmitted to His Excellency the Governor General by such members of this House as are of the honourable the Privy Council.

SUPPLY

Hon. W. S. FIELDING (Minister of Finance) moved that the House resolve itself into committee to-morrow, to consider of the supply to be granted to His Majesty.

Mr. MEIGHEN: I do not suppose it is really intended to go into committee to-morrow?

Mr. FIELDING: No, it is the usual formal motion made at the opening of the session.

Mr. MEIGHEN: I merely call attention to the fact that it does not seem necessary to be made. It is not in order now, we are not under motions.

Mr. FIELDING: This motion is always made at the beginning of every session. It is merely a declaration on the part of the House that it will grant supply at a later time.

Mr. MEIGHEN: I just call attention to the fact that it should be made under motions. We are under the Orders of the Day now.

Mr. FIELDING: It always follows immediately after the adoption of the Address. My hon. friend will see that if he consults the record.

Mr. MEIGHEN: Yes, but under motions.

Motion agreed to.

On motion of Hon. W. S. Fielding (Minister of Finance) it was ordered that the House resolve itself into a committee to-morrow to consider of the grants and means for raising the supply to be granted to His Majesty.

ADJOURNMENT—BUSINESS OF THE HOUSE

Mr. Mackenzie King moved the adjournment of the House.

Mr. MEIGHEN: What will be the business for Friday?

Mr. MACKENZIE KING: We propose to take up to-morrow government notices of motion if the House will give its consent.

Mr. MEIGHEN: What government notices of motion?

Mr. MACKENZIE KING: Those that appear in to-day's order paper: According to Friday's procedure they will be the first on the Orders of the Day to-morrow, and they have been on the order paper now for some days. I think members are all familiar with them, and I should imagine would be ready to proceed.

Mr. MEIGHEN: Is it intended to take up all the government notices of motion? There are six or seven of them.

Mr. MACKENZIE KING: That will depend entirely upon the length of the debate in each case. I think some of them are non-contentious and will occupy but a short time.

Mr. MEIGHEN: Will the Prime Minister give the order in which they will be taken.

Mr. MACKENZIE KING: I suggest that they be taken in the order in which they appear on the order paper.

Motion agreed to and the House adjourned at 1.28 a.m. (Friday).
