2. Is it the intention to include this type of art display in the Vancouver international airport?

Mr. Pickersgill: 1. The cost, in dollars, of the fine art works at the new air terminal buildings at Winnipeg, Edmonton and Toronto was \$270,000 which was one half of 1 per cent of the cost of the terminal projects.

2. A similar budget figure of one half of 1 per cent of the cost of the terminal project has been provided for fine art in the new Vancouver terminal building.

INCREASED IMPORTS FROM U.S.

Question No. 1,202-Mr. Mather:

What is the cause of the marked increase of Canadian imports from the United States in the first quarter of 1964?

The latest statistics available show that imports from the United States increased by 17.5 per cent from the first quarter of 1963 to the first quarter of 1964 whereas imports from all sources increased by 17.6 per cent. This rise in imports reflects sharply increased demands in Canada associated with the strong pace of expansion under way during the past year but is no doubt also attributable in part to the removal, effective the beginning of April 1963, of the remaining import surcharges which had been in effect since the exchange crisis of the preceding year.

WEIGHT OF PRODUCTS IN WAXED CONTAINERS

Question No. 1,204-Mr. Orlikow:

Have the weights and measures branch of the Department of Trade and Commerce and the food and drug directorate of the Department of National Welfare been able to decide between themselves which department is responsible for insuring that the contents of products in waxed containers are as indicated on the containers?

Miss LaMarsh: No problem has existed in this area for many years. The correct declaration of the net contents of prepackaged foods, including food products in waxed containers, falls within the jurisdiction of the Food and Drugs Act and regulations which are administered by the food and drug directorate of the Department of National Health and Welfare.
