#### TIGHT MONEY POLICY

### Question No. 447-Mr. Crouse:

- 1. Within the last twelve months, has the government, or the Bank of Canada as fiscal agent and with the knowledge of the government, taken any action or initiated any policy having or intended to have the effect of tightening the money supply in Canada?
- 2. Has the government any information to indicate that Canadian chartered banks are refusing loans to traditional customers?
- 3. If so, was this action the intended and logical consequence of the policy and action referred to in part 1?
- 4. If the answer to part 1 is in the affirmative, will the government give consideration to arranging or discussing with the Bank of Canada an exemption from such policy for the Atlantic provinces?

## Hon. Mitchell Sharp (Minister of Finance):

- 1. The rate of change in the money supply (i.e. in the total of currency outside banks and chartered bank deposits) within the last twelve months has varied in accordance with the circumstances and the increase in the year ending January, 1966, has been \$1,915,000,000 or 10.7 per cent.
- 2. While the government has no direct information on this subject, the demand for borrowed funds arising from the strong economic growth which has been taking place has been so intense that it is likely that some bank borrowers have been unable to secure as large loans as they would have liked. The chartered banks have tried to meet the normal borrowing needs of their traditional customers, particularly their smaller customers, and total chartered bank loans have increased by \$1,690,000,000 or by 17.7 per cent during the year ending January, 1966.
