CANADIAN INVENTORY OF HISTORIC BUILDINGS

- 1. How many persons will be hired to undertake the survey of historic buildings recently announced by the Department of Indian Affairs and Northern Development?

- 3. Is it the intention to hire persons through Canada Manpower Centers?
- 4. Is it the intention to hire persons who are unemployed?
- Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): 1. A total of 43 university students were employed between June and August, 1970 on the Canadian Inventory of Historic Buildings. At present 40 students are employed for the period between October 1970 and March 1971. It is expected that some 114 students will be hired for the summer of 1971. The hiring of students for this phase of the Inventory will continue to the early fall of 1972, by which time the requirement for their services will diminish sharply?
- 2. (a) For the summer of 1970 figures were as follows: British Columbia, 6; Alberta, 4; Saskatchewan, 3; Manitoba, 2; Ontario, 7; Quebec, 8; New Brunswick, 5; Nova Scotia, 5; Prince Edward Island, 1; Newfoundland 2. Total: 43.
- (b) Those now employed for the October 1970-March 1971 originate as follows: British Columbia, 6; Alberta, 4; Saskatchewan, 2; Manitoba, 3; Ontario, 7; Quebec, 7; New Brunswick, 5; Nova Scotia, 4; Newfoundland, 2. Total: 40.
- (c) For the summer of 1971: British Columbia, 9; Alberta, 7; Saskatchewan, 5; Manitoba, 5; Ontario, 13; Quebec, 52; New Brunswick, 7; Nova Scotia, 10; Prince Edward Island, 3; Newfoundland, 3. Total: 114.

NATIONAL PARKS-WATER QUALITY CHECKS

Question No. 487-Mr. Aiken:

- 1. Does the National and Historic Parks Branch of the Department of Indian Affairs and Northern Development maintain water quality checks on the waters within the national parks?
- 2. Do hotels in Banff National Park discharge raw sewage at any time of the year into Lake Louise and Moraine Lake and (a) if so, what action is being taken to eliminate the discharge of pollutants (b) if not, what was the source of pollutants found in these lakes during the summer of 1970?

Hon, Jean Chrétien (Minister of Indian Affairs and Northern Development): 1. Yes.

2. No. (a) Not applicable; (b) Fifty-nine streams and rivers were checked, 15 contained slight contamination and one heavy, this latter was posted. Wild animals are suspect as a contamination source. Louise Creek, outlet of Lake Louise suffered an oil spill from Chateau Lake Louise this past summer. A double trap system has been installed as a control measure. An old septic system and the Chateau Lake Louise Laundry are suspect as sewage and phosphate sources affecting Louise Creek. There is an algae which forms near the shoreline of Lake Louise during late summer. This algae turns brown and somewhat foul in time. An inadequate leaching pit of Moraine Lake Lodge caused pollution of Moraine Lake until September 1969. Two new leaching pits were installed in series. There was no observed pollution in 1970. There is a water bleeder pipe 1" in diameter near Moraine Lake boat dock. This has not been used for six years and will be removed this winter. The Moraine Lake campground septic disposal system was inoperative for several weeks this summer. It is possible that campers may have emptied chamber pots into Moraine Creek during this time. Also, a septic tank pumpout service vehicle was apprehended this summer for depositing sewage into a creek a mile from Moraine Lake.
