## LOSS OF EXPORTS AS A RESULT OF IMPOSITION OF UNITED STATES SURCHARGE

### Question No. 152-Mr. Orlikow:

- 1. What is the estimate by the government of the loss of exports (not the exports affected) by the imposition of the United States surcharge?
- 2. What was the estimate of unemployment for the next 12 months made by the government before President Nixon imposed the ten percent surcharge?
- 3. What is the present estimate of unemployment for the next 12 months made by the government?
- Mr. J. A. Jerome (Parliamentary Secretary to President of the Privy Council): I am informed by the Departments of Industry, Trade and Commerce and Finance as follows: 1. The survey carried out in August 1971, by the Department of Industry, Trade and Commerce of 1,300 firms affected by the surcharge suggested that the direct loss of export sales at annual rates could approach \$400 million after three months, \$700 million after six months and \$900 million after one year. The Department has not attempted to assess the actual loss of affected exports in relation to these estimates because of the difficulty of isolating the effects of the surcharge from other factors which have influenced Canadian merchandise exports.
