Hon. Marc Lalonde (Minister of National Health and Welfare): Yes; (a) Subsidies have been provided to the council since 1921-22 under its initial name of the Canadian Council on Child Welfare and then under its subsequent names of the Canadian Council on Child and Family Welfare (1934), the Canadian Welfare Council (1935), and the Canadian Council on Social Development (1970); (b) In 1970-71 a \$30,000 grant was made to the Canadian Welfare Council (now the Canadian Council on Social Development) by Correctional Services, Department of the Solicitor General (Canadian Penitentiary Service). This amount was added to Health and Welfare's sustaining grant of \$90,000; (c) Year 1971-72, amount \$205,-000; year 1972-73, amount \$275,000; year 1973-74, amount \$275,000; (d) A capital grant of \$62,500 was awarded for the council's building expansion program through Supplementary Estimates in 1969-70.

2. (a) The construction of a new Rideau Canal headquarters at Smiths Falls must, of necessity, be deferred and funds reallocated to the higher priority of rehabilitating locks and dams necessary to keep the system in operation; (b) Design for the new headquarters building will be completed in 1975-76 and funds are tentatively scheduled for its construction in 1976-77.
