Oral Questions

Right Hon. P. E. Trudeau (Prime Minister): The hon. member refers, as I believe the Leader of the Opposition did, to decisions of the Anti-Inflation Board. The only decision of which I am aware is that they are carrying out their mandate in this particular case by talking to the parties to the dispute. One of the parties is the Government of Canada, and that means all the ministers on this side of the House.

Mr. Lawrence: A supplementary question, Mr. Speaker. According to press reports, as late as three quarters of an hour ago a decision had been handed down by the Anti-Inflation Board. But whether it has or has not, may I get down to brass tacks and ask the Prime Minister whether the cabinet would be willing to hear a joint appeal by the metro Toronto school board and the metro Toronto secondary school teachers federation regarding the decision of the Anti-Inflation Board of 10 days ago?

Mr. Trudeau: Mr. Speaker, once again, as I did in reply to the Leader of the Opposition, I refer the hon. member to the statute which is in the process of being passed and which will soon be proclaimed, or to the white paper, where he will see what procedure has been laid out. The hon. member refers to a decision of the Anti-Inflation Board, a recent one, he says. No member on this side is aware of any such decision, so if the hon. member has information I wish he would lay it before the House.

CHILE—CANADIAN SUPPORT FOR EXAMINATION OF ALLEGED VIOLATIONS OF HUMAN RIGHTS

Mr. David MacDonald (Egmont): Mr. Speaker, my question is for the Secretary of State for External Affairs, but in his absence it might be directed to the Prime Minister. With respect to the vote at the United Nations yesterday concerning the situation in Chile, when the assembly registered its profound distress at the constant and flagrant violations of human rights, a vote that Canada supported, in view of the comments made at that time by our delegate to the third committee that Canada was not totally accepting the conclusions of the report of the special working group because it was not able to enter Chile to observe and make inquiries first hand, would the government take further action directly through diplomatic channels with the government of Chile in order that there can be a full and complete examination of the situation in that country?

The hon. member points out the concern we have always felt in the past with regard to the situation in Chile. At the time, we protested against the fact that no international commission could go and see on the spot what was going on there. We will continue to do so. Our positive vote yesterday, at the United Nations, in favour of human rights being respected in Chile proves indeed that we will continue to do so.

SUGGESTED INVESTIGATION OF ALLEGATIONS OF AUDITOR GENERAL CONCERNING FINANCIAL SITUATION

Mr. Lambert (Edmonton West): A supplementary question, Mr. Speaker, which I will direct to the President of the Treasury Board. Does the minister agree that if the practice followed by AECL were followed by a public company in this country, the legal consequences could be very serious indeed?
