BUSINESS OF THE HOUSE

Mr. Robinson (Burnaby): Madam Speaker, I have a question for the President of the Privy Council (Mr. Pinard) concerning the business of the House, if I may have his attention for just a moment. It concerns an important piece of legislation, Bill C-43, the Freedom of Information Act. Would the government House leader give some indication of when this important piece of legislation will be brought before the House for second reading? He is aware of the fact that my party has indicated its desire to have the legislation expedited at second reading. We are prepared to co-operate as we did on the previous bill to see this legislation get into committee quickly for a full and comprehensive study. It is an important bill. Would the government House leader indicate when the freedom of information legislation will be brought forward for second reading?

Mr. Pinard: Madam Speaker, I welcome very much the offer of co-operation from the hon. member on this particular bill. I can assure him that at the first opportunity I will make sure that this bill is brought forward for discussion at second reading. The hon, member knows that during the coming days we must deal with the Bank Act before November 30. In order to cope with the parliamentary calendar for this month, I held a House leaders' meeting last night, and I will hold a meeting tonight. I indicated to the House leaders last night that it would be possible, if we have collaboration from both opposition parties, to be in a position to deal with the second reading stage of both the legislation on the access to information and on the Post Office. However, there will be further consultation and discussion with the House leaders. In so far as we are concerned, we are very keen to deal with this bill and to send it to committee. But it all depends on the co-operation we receive from the party of the hon. member and from the Conservative party.
