Mr. Dan Heap (Spadina): Mr. Speaker, I have a petition from a number of residents of Canada who are asking Parliament to address the situation in which employees who are now laid off will lose part of their unemployment insurance pay if they had earned severance pay during their past employment.

Mr. Simon de Jong (Regina East): Mr. Speaker, I have a similar petition from a number of Canadians who are protesting the mean-spirited changes in the Unemployment Insurance Act. They humbly pray that Parliament will address their concerns and are presenting this petition despite the mean spirit of the Minister of Finance (Mr. Wilson) and his colleagues.

IMMIGRATION ACT, 1976

MEASURE TO AMEND

Mr. Dan Heap (Spadina) moved for leave to introduce Bill C-232, an Act to amend the Immigration Act, 1976 (determination of refugee status).

Mr. Speaker: Shall the Hon. Member have leave to introduce the said Bill?

Some Hon. Members: Agreed.

Mr. Heap: This Bill formerly known as C-219, requires that all refugee applicants in Canada should have the opportunity, if they wish it, of an oral hearing before the Refugee Status Advisory Committee. At present the law does not provide for that. That is one of the reasons we have many thousands who are waiting to have their status determined. This Bill will not only provide fairer opportunity for judgment by the Refugee Status Advisory Committee but will also shorten the time of waiting to the benefit of both the refugee claimants and the staff of the Department.

Motion agreed to, Bill read the first time and ordered to be printed.

SUPPLEMENTARY FISCAL EQUALIZATION PAYMENTS 1982-87 ACT

MEASURE TO ENACT

Hon. Michael Wilson (Minister of Finance) moved for leave to introduce Bill C-39, an Act to provide for the making of supplementary fiscal equalization payments to certain provinces for the period April 1, 1982 to March 31, 1987.
