## REQUEST THAT MINISTER RESIGN

Ms. Lynn McDonald (Broadview—Greenwood): Mr. Speaker, an hour ago at the press conference the Hon. Member for Ottawa—Vanier would not join with me in calling for the Minister's resignation. I am glad to see he has changed his mind.

I would like to ask the Minister a question. If she cannot defend a CRTC decision, a decision of an independent agency, where the merits of the application that was approved were clearly superior to the merits of the application that was denied, if she cannot defend this decision against the goon squad in her own caucus—

Some Hon. Members: Oh, oh!

**Ms. McDonald:** —how can she usefully serve as Minister? Should she not now do the honourable thing and resign?

Hon. Flora MacDonald (Minister of Communications): Mr. Speaker, one thing we do believe in doing is following the dictates of the law. That seems to be beyond the sensibilities of the Member who has just spoken. We have advice from the Department of Justice as to the procedures to be followed, but it is terribly important that we recognize the concerns that do exist. I mentioned one, the concentration. I just want to say as well to the Hon. Member that we also have a concern about services in both the French and English languages in this country.

I would like to ask why she misled the press conference earlier today and came up with a false issue and stated that Francophone taxpayers would be required to pay for this service when that is contrary to what the CRTC said, that the money would come from advertising and subscribers? Why is the Minister setting the Francophone community against the Anglophone community in this case? Why does she not respond to the needs of the Francophone community, but act immediately now on the application which has been fully justified before the CRTC for the All-News Channel?

Hon. Flora MacDonald (Minister of Communications): Mr. Speaker, I would be glad to send a copy of the ruling of the Department of Justice to the Hon. Member so she will understand when the appeal period exists. I also want to say to her that as a Government we have recognized the needs of the French-speaking communities, in the Province of Quebec and all across the country. We will be seeing, through the introduction of our official languages legislation, just how important this is not only in the Province of Quebec, but elsewhere in Canada.

#### THE SOLICITOR GENERAL

PROMISE CONCERNING ANTICIPATED PENSIONS AFTER 25 YEARS OF SERVICE FOR CORRECTIONAL SERVICES EMPLOYEES—GOVERNMENT POSITION
