PETRO-CANADA

Mr. Scott Thorkelson (Edmonton—Strathcona): Mr. Speaker, the Petro-Canada International Assistance Corporation has withdrawn its scholarship support for the University of Alberta Summer Petroleum Program.

Petro-Canada arrogantly withdrew its support without notifying the University of Alberta, forcing the cancellation of the program. The Summer Petroleum Program has trained over 300 people from developing countries in the last seven years.

SCOTIA SYNFUELS PROJECT

The Scotia Synfuels project could mean a revitalization of the island's economy.
