The Court of Appeal Delivers a Number of Interesting Judgments - Emphasis Get Damages - Partnership Suits.

In re Queen's Council of the Court of Appeal (dec'd), ch. 3, the Lieutenant-Governor of Ontario in Council has the right to appoint Ontario's council to take precedence over all others in Ontario.

In Garofalo v. Harris the facts were that the defendant conveyed certain land to his daughter while an action for slander was pending against him.
