



**The Massacre of Naardne**  
No more striking instance of the barbarity which accompanied the Spanish war in the Netherlands can be furnished than the atrocious massacre perpetrated within the little town of Naardne, in North Holland, in November, 1572. Following the suppression of open rebellion through out the southern districts of Holland, Don Frederic, son of the Duke of Alva, commanding the Spanish forces was sent with an army to operate against the towns which still held out in the Upper Provinces. The little city of Naardne, on the coast of the Zuyder Zee lay in his path, and had not yet formally submitted. A company of one hundred troopers was therefore sent forward to the city gates to demand instant surrender, and though the small garrison were disposed to yield, the stout hearts of the burghers forbade them to submit without a struggle. Unfortunately as the Spanish deputation was returning with their refusal a lunatic mounted one of the ramparts and fired into the soldiery, and though no one was injured the act infuriated the Spanish commander to dire revenge. The order went forth that the town must be taken and destroyed and that no single person should be left alive - a command which was almost literally obeyed.

**NOTICE OF REAL ESTATE SALE**  
Pursuant to the authority of a license, to me for that purpose, granted by the Probate Court for the County of Charlotte, on the Seventeenth Day of July A. D. 1909, there being a deficiency in the personal estate to pay the debts and costs of administration, in the estate of Daniel Campbell, late of Saint George in the County of Charlotte, intestate, deceased, I will sell at public auction, to the highest bidder, at or near Youngs Bridge, so called, in the Parish of Saint George in the County of Charlotte, at two o'clock in the afternoon on Saturday the twenty first day of August next, in separate parcels, all the real estate of which the said Daniel Campbell died seized and possessed, and which is described as follows, in the said license from the said Probate Court: - (1) All that certain lot, piece or parcel of land lying and being in the said Parish of Saint George commencing on the north line of land owned by the late Hugh Mattheson, commonly called the Daily lot, on the road leading from the late Israel Thorne to the Second Falls, thence easterly along the said Daily line to the west line of the Bay of Fundy Company's Lands, thence following the said line North to the south line of land formerly owned by the late Robert Grey, thence westerly along said line and prolongation thereof to the south side of the Ash property thereof to the Magaguadavic River thence southerly along the east bank of the said River to the north line of the Taylor lot, so called near a gully on the interval, thence east along the said line to the aforesaid road, thence south along the said road to the place of beginning and being a part of the land formerly in the occupation of Thomas Moreland.

(2) Also a lot described in a deed from Phoebe Kelley to Thomas Barry, registered in Charlotte County Records in book 12 pages 291 and 292 and therein described as follows: - Also a piece of land situate on the south side of the first above tract and lying between the river and the road leading to the Upper Falls, containing about two acres as now fenced and occupied by Stephen Kelley in his life time, and which said lot is commonly known as the Kelley lot. (3) Also an undivided half interest in that certain lot of land and premises situate in the Parish of Saint George in the County of Charlotte and bounded on the west by the River Magaguadavic, on the north and east of lands of Lewis Delman and on the south by lands of Fred Baldwin or John Thorne and being the same premises upon which the said Daniel Campbell resided at the time of his death, with the buildings and erections thereon being.

**pillage ran riot, the ferocity of the Spaniards being vented alike on men, women and children. Houses were rifled of their contents, and their inhabitants prodded by rapiers were forced to convey the booty to the camp, a fatal thrust being given them for their refusal. The town was then fired from every side that no fugitive should escape, and none survived except by accident. A body of some hundred burghers sought flight across the open country, but most of them were overtaken, stripped of their outer clothing and hung upon nearby trees to perish by a lingering death in the bitter weather. Twenty of the wealthiest after fearful torture, purchased their lives of their inhuman prosecutors, but the principal burghmaster, after paying ransom, was by order of Don Frederic hanged to his own doorway, and his severed limbs were placed over the city gates.**

Few citizens and no soldiers escaped from the massacre and the destruction, and for three weeks none were suffered to approach the scene from without, to give burial to the slain. Shortly afterward the fortifications were dismantled, and the walls were razed to the earth, so that for a long time, Naardne literally ceased to exist.

The army was brought up from Bussem the same evening and Don Frederic proceeded to invest the city. This time, however, a deputation of the citizens empowered to surrender was sent out to them, and an officer Romero, commissioned to treat with them, demanded the keys of the city, promising at the same time that the lives and property of the citizens should be spared. To attest his word, he gave his hand to the leader of the deputation in sight of the soldiery and the whole party accompanied by about six hundred musketeers, entered the city. There a sumptuous repast was prepared and by the wives of the citizens, and the Spaniards were entertained in a hearty manner in the town hall. When the feast ended, the great bell was rung to call the citizens to a conference in the building, and when five hundred had entered to ascertain the will of the conquerors, Romero advanced within the door and bade them prepare for death. At the same moment, the door was surrendered by a horde of armed Spaniards, and these rushed across the threshold and opened fire upon the defenceless victims of their perfidy. Regardless of prayers and pleas, the butchery proceeded, and in a few moments the work of death was completed within, and was carried forward with equal rapidity without the building, which was at once fired. Outside in the streets carnage and
