Resolved that the sum of £6 : 4 be granted to *Wm. Durant & Co.* for Printing Proclamations, &c.

Resolved that the sum of £49 : 10 be granted to the Secretary of the Province, for his account for issuing Warrants.

Resolved that the sum of £89 : 1 : 3 be granted to His HONOR the PRESIDENT, to pay the balance of *Robert Smith's* account for repairs on the Province-Hall.

Resolved that the sum of £20 : 7 : 6 be paid to the High Sheriff of the County of York, being the amount of his account for sundry services performed to this Province, in the execution of the duties of his Office.

Resolved that there be paid to *John Robinson, Esq.* the sum of £5 : 14 for Postage of Public Letters.

Resolved that there be granted to Commissioners, to be appointed by His HONOR the PRESIDENT, the sum of £100 in aid of a large individual subscription, made for the erection of a Church in the Parish of Chatham, in Northumberland.

And the like sum of £100 also in aid of an individual subscription, made towards building and completing the New Church at Beaubair's Point in said County.

Resolved that the sum of £200 be granted to *Thomas Wetmore, Esq.* His MAJESTY's Attorney General, for past services.

Resolved that the sum of £100 be allowed to *J. M. Bliss, Esq.* for his past services as Solicitor General.

Resolved that the sum of £100 be granted to His HONOR the PRESIDENT, to be vested in the hands of such persons as he may appoint, to enable the Society of Calvinistic Baptists in Fredericton, to discharge a Debt incurred by them in the erection of their Meeting-House in that Town.

Resolved that the sum of £50 be granted to His HONOR the PRESIDENT, to be vested in the hands of such persons as he may think fit to appoint, to enable the Society of Methodist in Fredericton, to discharge a Debt by them contracted in the purchase and fitting up a Chapel in that Town.

Resolved that the sum of £100 be granted to His HONOR the PRESIDENT, for the purpose of assisting the Roman Catholics in the City of St. John, to finish their Chapel in the said City.

Resolved that the sum of £150 be granted to His HONOR the PRESIDENT, to be applied by His HONOR in further aid of the Members of the Kirk of Scotland, in completing the Church erected in the City of St. John.

Resolved that a sum not exceeding £500 be granted in addition to the former grant to the Mayor, Aldermen and Commonalty of the City of Saint John, for the purpose of assisting in erecting a Pier or Break-water, to be erected at Battery point.

Resolved that the sum of £200 be granted in aid of individual subscriptions towards finishing a Church in the Parish of Sheffield, for the established Kirk of Scotland, to be vested in the hands of such persons as His HONOR the PRESIDENT may appoint.
