Mr. Speaker reported that when the House did attend the Honourable the Deputy Governor General in the Senate Chamber, His Honour was pleased to give, in Her Majesty's name, the Royal Assent to the following Bills:

Bill C-59, An Act to provide for the resumption and continuation of longshoring, checking, cargo repairing and related operations at certain ports in the Province of Quebec.—Chapter No. 39.

Bill C-43, An Act to amend the Law Reform Commission Act.—Chapter No. 40.

Bill C-48, An Act to amend the Railway Act.—Chapter No. 41.

Bill C-26, An Act to amend the Civil Service Insurance Act.—Chapter No. 42.

Bill S-9, An Act to repeal the Proprietary or Patent Medicine Act and to amend the Trade Marks Act.—Chapter No. 43.

The House resumed consideration in Committee of the Whole of Bill C-32, An Act to impose a charge on the export of crude oil and certain petroleum products, to provide compensation for certain petroleum costs and to regulate the price of Canadian Crude oil and natural gas in interprovincial and export trade and progress having been made and reported, the Committee obtained leave to consider it again at the next sitting of the House.

A Message was received from the Senate informing this House that the name of the Honourable Senator Godfrey had been substituted for that of the Honourable Senator Benidickson on the list of Senators serving on the Special Joint Committee on Immigration Policy.
