

Of the Buffalo Railway Company ; praying for the passing of an Act changing its name to "The International Railway Company."

Of C. J. Grantham and others, of the City of Hamilton, and others of elsewhere ; praying for the passing of an Act incorporating them as "The Cosmos Cotton Company."

Of the Quebec and Lake Huron Railway Company ; praying for the passing of an Act extending the time for the commencement of the construction of their works and for other purposes.

Of the Ontario, Hudson's Bay and Western Railways Company ; praying for the passing of an Act extending the time for the commencement and completion of the said railway.

Of the Counties Councils of the County of Waterloo, and the United Counties of Stormont, Dundas and Glengarry ; severally praying for the passing of such legislation as will lessen the liability to accident at Railway Crossings. Compel the placing of watchmen at the more dangerous crossings or elevating the railway tracks. Control the speed of trains while crossing streets in cities and towns, and compel the Railway Companies to furnish particulars and statistics, showing the number of accidents annually at Railway Crossings and deaths resulting therefrom.

The Honourable Mr. Scott, Secretary of State, presented to the Senate,—The Report of the Department of Trade and Commerce for the Fiscal Year ended June 30th, 1901.

Ordered, That the same do lie on the Table, and it is as follows :—

The Honourable Mr. Bernier moved, seconded by the Honourable Mr. Forget,

That an humble Address be presented to His Excellency the Governor General ; praying that His Excellency will cause to be laid before the Senate, copies of all Orders in Council, documents, memorandums, or other papers, relating to the transfer, from the Federal to the Provincial control, of public lands allotted for education in Manitoba, or relating to the payment by this Government to the Manitoba Government of any money—whether it be on the capital or on the interest—derived from the sales of such lands ; also copies of all correspondence between the Government or any member thereof, and the Government of Manitoba or any member thereof, or any other persons, up to this date, in connection with the above matters.

The question of concurrence being put thereon, the same was resolved in the affirmative ; and it was

Ordered, That the said Address be presented to His Excellency the Governor General by such Members of this House as are Members of the Privy Council.

The Honourable Mr. Scott moved, seconded by the Honourable Mr. Templeman,

That, pursuant to Rule 79, the following Senators be appointed a Committee of Selection to nominate the Senators to serve on the several Standing Committees during the present Session, namely :—The Honourable Sir Mackenzie Bowell, Honourable Messieurs Templeman, Ferguson, Dandurand, Miller, Ellis, Loughheed, Jones, and the mover, and to report with all convenient speed the names of the Senators so nominated.

The question of concurrence being put thereon, the same was, on division, resolved in the affirmative, and

Ordered accordingly.

Then, on motion of the Honourable Mr. Scott, seconded by the Honourable Mr. Templeman,

The Senate adjourned.
