- 3. The agreement entered into with the corporation of the town of Port Hope was the standard municipal agreement and covers the following points:
- (1) The town shall convey to Wartime Housing Limited improved property for \$1 per building lot.
- (2) Wartime Housing Limited shall construct houses in accordance with plans and specifications filed with the town clerk.
- (3) Wartime Housing Limited shall have the privilege of leasing the houses to servicemen and/or their dependents at rents ranging from \$22 to \$30 per month per house.
- (4) Wartime Housing Limited at its own cost and expense shall carry out the management and control of the houses and shall repair, maintain and keep the houses in good and substantial repair.
- (5) The town shall provide such facilities, privileges and services as are furnished or made available to other property owners and tenants.
- (6) Wartime Housing Limited shall pay in lieu of taxes, for services rendered and privileges and facilities made available, the sum of \$24 per annum for each house containing two bedrooms; and \$30 per annum for each house containing more than two bedrooms. Such payments to be pro-rated during the first year.
