LABOUR CONDITIONS

SUGGESTION MINISTER REPORT ON MEASURES TO DEAL WITH STRIKES AND WORK STOPPAGES—MOTION UNDER S.O. 43

Mr. Walter Baker (Grenville-Carleton): Mr. Speaker, under the provisions of Standing Order 43 I request the unanimous consent of the House to move a motion on an urgent matter, namely the production lost to Canada due to strikes and work stoppages.

The Prime Minister himself stated at the first ministers conference this morning that Canada has the second worst record in the world for production days lost due to work stoppages and strikes.

I therefore move, seconded by the hon. member for Brandon-Souris (Mr. Dinsdale):

That the Minister of Labour be instructed to report back to the House within a week what steps his department is taking to rectify this serious situation which is crippling the economy, especially at a time when the country is plagued with rising unemployment and low economic production.

Mr. Speaker: The motion is put forward under the terms of Standing Order 43 and cannot be presented without the unanimous consent of the House. Is there unanimous consent?
