

There must be an amendment to the Human Rights Act as was requested by the all-party committee on AIDS and as has been promised by this government. If we are truly concerned about the treatment of people with AIDS, we must be concerned about more than just their medical treatment. We must be concerned about their rights and the quality of their life.

Third, we must commit ourselves to expanding research aimed at improving our knowledge and finding a method of eradicating this disease.

Fourth, we must continue our fight against AIDS on a global basis. Canada must continue to help, particularly developing countries, with treatment, education and prevention in AIDS.

During AIDS Awareness Week, I trust all members of this House will lead the way in helping all Canadians understand that AIDS affects the total community. AIDS awareness is not enough. We must commit ourselves to an action plan that improves the care of people living with AIDS and HIV, and an action plan that increases our research so that we may eradicate this disease.

INTERPARLIAMENTARY DELEGATION

PACIFIC PARLIAMENTARY LEAGUE FOR EDUCATION CULTURE AND ECONOMIC CO-OPERATION

Mr. Robert Wenman (Fraser Valley West): Mr. Speaker, pursuant to Standing Order 34, I have the honour to present to the House, in both official languages, the report of the preparation meeting for the establishment of the Pacific Parliamentary League for Education, Culture and Economic Co-operation held the 26th and 27th in Singapore.

This meeting was extremely important to Canada because Canada sells more of its exports to Asia-Pacific markets than to all of Europe. Three of Canada's largest six markets in the world are in Asia. Eight out of twenty of Canada's strongest markets in the world are in the Pacific region and 42 per cent of immigration to Canada comes from this region.

Therefore, the establishment of a new interparliamentary organization is of new and continuing importance.

Routine Proceedings

The member for Saint-Denis and myself urge the Canadian Parliament and the Canadian government to send representation to the foundation meeting that will be held in Canberra in December.

We present this report and urge that it be followed up with the interest and concern of the government and the Speaker.

JUSTICE AND THE SOLICITOR GENERAL

SECOND REPORT OF STANDING COMMITTEE

Mr. Bob Horner (Mississauga West): Mr. Speaker, I have the honour to present, in both official languages, the second report of the Standing Committee on Justice and the Solicitor General.

This report, unanimously adopted, is the result of consideration of the uncensored and unexpurgated versions of the reports to Corrections Service Canada by, one, Mr. Weir concerning the escape of Daniel Gingras in the province of Alberta and, two, by the Board of Investigations concerning an offender, Allan Legere, unlawfully at large in the province of New Brunswick.

Mostly to clarify and reinforce the rights and privileges of Parliament and its committees, the committee recommends that the Privacy Act, the Access to Information Act and the Canada Evidence Act be amended to require government institutions holding personal information records or information to produce them in their unexpurgated form when properly ordered to do so by either the Senate or the House of Commons.
