I enjoy being at the service of the House and I do try to do my best. I am not a robot and I am not a perfect person. I am just a member of Parliament like all of you. I do thank all those in House for their collaboration and understanding. I can assure them that I will continue to do my best to be a good servant of the house.

Some hon. members: Hear, hear.

Mr. Dingwall: Madam Speaker, I just wish to reaffirm our support of the Chair and of its decisions both today and on prior occasions.

I believe it to be quite important for future deliberations that the suggestion by my hon. friend opposite be given serious consideration. The hon. member stated that he was third on a list that was given to the Speaker. The Speaker did not get to him because the second person on the list did not get reached. There is still a way for hon. members who do have questions to be able to put them. If there was a disposition in the House, unanimous consent could extend the length of Question Period in order to accommodate that particular member.

I want to concur with the comments of the government House leader that the substantive aspects of Question Period ought to be reviewed in some form. We all know that the management committee has a subcommittee that is looking at some of those aspects. However I do not want it to be implied in any way, Madam Speaker, through you or from members opposite that the fundamentals and traditions of Question Period would be markedly changed in any way by those discussions that would be taking place in the subcommittee.

In conclusion I would say that I understand the difficulties the Chair has in recognizing members that wish to be recognized in Question Period. That is why we have tried to facilitate the Chair in providing a list from this side. I think it is only reasonable when you have 300 members of Parliament who are in the House at any given point in time that wish to be recognized for any particular thing. It is somewhat new to find out that the government now has a list that it submits on a regular basis. We were under the clear belief and understanding that Question Period was probably one of the most primary tools available to opposition parties and opposi-

tion members in order to make the government accountable for its particular actions.
