## **HOUSE OF COMMONS**

That this House direct that such constituency reports have deleted therefrom the references to which I have already referred.

#### CRIMINAL CODE

BILL TO AMEND SECTIONS DEALING WITH SOLICITING AND PROSTITUTION—MOTION UNDER S.O. 43

Mr. Eldon M. Woolliams (Calgary North): Mr. Speaker, I rise, under the provisions of Standing Order 43, to seek the unanimous consent of the House to discuss a motion relating to a matter of urgent and pressing necessity.

The cities of Vancouver and Toronto, and other major urban centres, have requested an amendment to the Code in reference to solicitation and prostitution to restore order on their streets. All parties have agreed to have this amendment severed from omnibus Bill C-21. I therefore move:

That the government bring forward this bill forthwith without delay, and in consequence that it be approved by parliament expeditiously, so as to prevent the

error made by the Prime Minister when he was minister of justice, of removing a similar clause dealing with the same when the vagrancy section of the Code was totally repealed.

Mr. Speaker: Such a motion can be presented for debate at this time only with the unanimous consent of the House. Is there unanimous consent?

Some hon. Members: Agreed.

## AIR TRANSPORT

REQUEST FOR IMPROVED FACILITIES AT YORKTON AIRPORT— EAST-WEST SERVICE—MOTION UNDER S.O. 43

The city of Yorkton neither needs nor wants the air route awarded to Norcanair by the Canadian Transport Commission. Considering that Norcanair has failed to inaugurate this service, violating the CTC's requirement that service commence within six months of July, 1978, I move, seconded by the hon member for Winnipeg North Centre (Mr. Knowles):

That the Minister of Transport provide at once the necessary assistance to improve the maintenance and runways at Yorkton airport, and that he assist the city in attracting east-west air service from Transair to the extent, if necessary, of providing operating subsidies on this route.
