PACIFIC MAIL BOAT ASHORE

Steamer Mongolia Ran Ashore Near Tokio This Morning--No Loss of Life.

TOKIO, April 22--The Pacific mail S. Mongolia ran ashore this morning in a locality full of reefs. The steamer lies near shore within reach of rescue from all directions. Her proximity to land prevents any possible loss of life.

FEAR FOR THE "NANNA"

Norwegian Steamer from Portland to Hillsboro May Have Foundered.

HOPWELL CAPE, N. B. April 19--Grave fears are entertained for the safety of the Norwegian steamer "Nanna" Capt. Nacro. She sailed on Friday 12th inst from Portland, Me. for Hillsboro, N. B. for plaster. The time required for the voyage is about 36 hours. The S. S. "Hird," which arrived here on Wednesday, reports she met the "Nanna" coming out of Portland on Friday 12th inst. The snow storm set in on Saturday and it is feared she may have foundered. If simply disabled she should be reported before this.


Weather Changes Damage Fruit Crops in South Western States.

NEW YORK HAS NEW SENSATION NOW

Wealthy Philadelphian Committed Suicide in a Hoboken Hotel Shortly After His Arrest on a Serious Charge--Cut His Throat With Broken Glass.

NEW YORK, April 22--Benedict Gimbel, the wealthy Philadelphia merchant who cut his throat with a piece of broken glass in a hotel in Hoboken soon after he had been arrested on serious charges in this city, died in St. Mary's hospital, Hoboken, shortly before three o'clock this morning. His wife was at his side, with his two brothers, who came here at once on receipt of word of his trouble, one from Milwaukee, and the other from Philadelphia. His personal physician, summoned from Philadelphia, was also present.

A SUNDAY FIRE IN FREDERICTON

FREDERICTON, N. B. April 22--(Special)--The double brick tenement house at Margaret owned by Alexander Gibson and occupied by John Stafford and C. F. Morhouse, was totally destroyed by fire yesterday. The flames started in the roof near the chimney and as a strong wind prevailed at the time the fire gained great headway. A shingle mill on the upper side of the Nainiwak caught fire but suffered no damage. The loss is in the neighborhood of \$2000 partly covered by insurance.

NEW ALDERMEN FORMALLY DECLARED ELECTED TODAY

A special meeting of the common council was held this morning at 11 o'clock. Deputy Mayor Tilley presided, and there were present: Ald. Lewis, Hamm, Lockhart, Sproul, Vanwart, McGoldrick, Holder, Willett, Baxter, Rowan and Christie, with the recorder and common clerk. The recorder stated that the meeting was called in order that he should receive power to make a demand on Messrs. Smith, Quinn and J. J. Gordon in connection with the strips of land on the west side, which were taken over by the city on the expiry of the leases and for which the assessors demanded the award of the valuator. The recorder then read two resolutions dealing with the matter which were, on motion of Ald. Willett, adopted. They gave the recorder power to make a demand on the lessees for the lands in question.

A report from the treasury board recommending that Wm. Griffiths be appointed as commissioner of Stanley ward in place of John Stephens, resigned, was adopted.

EQUITY COURT

The case of Michael Farrell vs. The Portland Rolling Mills Company for the recovery of \$3,000 which he paid the company for stock sold to him two years ago, was argued, under misrepresentation, came up in the equity court before Judge Barker this morning. The bill and answer were read and part of the evidence of Eben Perkins, former superintendent of the company taken before a commission in Chicago. In connection with this evidence the question was raised as to the admissibility of Mr. Perkins' evidence because of his religious belief. Judge Barker, however, held that the evidence was admissible.
