Stanley E. Elkin declared that he was interested in harbor development. He thought when adequate information had been secured that the committee should decide how to proceed. There was the question as to whether the wishes of the majority would carry and also as to whether his ideas would be acceptable. The all-powered press in St. John might be against it. This was very important.

Mr. McCready said the information had to be obtained before a conclusion could be reached. Anything else was putting the cart before the horse and was not business to decide in advance of the evidence.

Commissioner Bullock voiced the belief that St. John should have harbor commission and the sooner the better. W. F. Burditt could not see why the committee should not deal with these matters at once. Let the breakwater come first, and then the wharves and piers. If it was intended to have a harbor commission it was a waste of time to do the work. A complete study of the problem was too big for this committee. They should be going to the question of harbor commission, and then state the terms upon which the commission would operate.

Commissioner Frink reiterated the things Commissioner Bullock had said were absolute necessities and asked if harbor commission would remedy things now. Harbor commission had been defeated three times. In the meantime, why wait? There was an agreement—the tri-partite—with the government to do the work with the exception of the continuation of the breakwater, and it was still valid and binding. The government had built warehouses at berths 6, 15 and 18. Why not ask the government if it was willing to carry out its contract? Seven or eight millions of dollars had been spent; why not go on? Sir Douglas Haasen had got grain conveyors at nos. 5 and 6 when in the cabinet. This was on the city's property but the government had paid for it. He realized, he said, that the government had many demands on it, but a committee should go to Ottawa and put the demands before the minister, asking if financial provision could be made. If not, the answer was "No." But if some of the work could be undertaken, well and good. The personal touch was better than a barrel of letters.

Delegation to Ottawa Discussed. P. A. Dykeman urged the sending of a delegation to Ottawa. He thought many members of the committee were lacking in information and that there should be a comprehensive statement before each member. He made a motion that the meeting take steps to appoint a delegation to proceed to Ottawa.
