INCORPORATION OF UNIONS

Question No. 2,420-Mr. Robinson:

Is it the government's intention to require the Canadian incorporation of all unions operating in Canada and, if so, will they be subject to the same rules and regulations as laid down in the Canada Companies Act?

Hon. Bryce S. Mackasey (Minister of Labour): Matters related to this question are involved in the report of the Task Force on Labour Relations and are being studied in the course of considering amendments to the IRDI Act. Until this study is completed, it is not possible to predict government action.
