

On motion of the Honorable Mr. *Macdonald* (*Cornwall*), seconded by the Honorable Mr. *Holton*,

*Resolved*, That an humble Address be presented to His Excellency the Governor General, praying that His Excellency will be pleased to recommend an appropriation of \$500 to procure a Bust of the late Honorable *Robert Baldwin*, for the Parliament House; and assuring His Excellency that this House will make good the same.

*Ordered*, That the said Address be presented to His Excellency the Governor General, by such Members of this House as are of the Honorable the Executive Council of this Province.

On motion of the Honorable Mr. Attorney General *Macdonald*, seconded by the Honorable Mr. Attorney General *Cartier*,

*Resolved*, That it is expedient that at the first Election for the District of *Algoma*, both for the General and Local Legislatures, all persons otherwise qualified, except in respect to real property, who are householders, shall have the right to vote at the said Election.

On motion of the Honorable Mr. Attorney General *Macdonald*, seconded by the Honorable Mr. Attorney General *Cartier*,

*Resolved*, That an humble Address be presented to His Excellency the Governor General, praying that His Excellency will be graciously pleased to cause adequate compensation to be paid to the Volunteers who have been wounded or have otherwise suffered during the late lawless invasion of the *Niagara* Frontier, and to the families of those who were killed or died during service on such Frontier, and this House pledges itself to make good the same.

*Resolved*, That an Humble Address be presented to His Excellency the Governor General, praying that His Excellency will be graciously pleased to cause a gratuity, equal to one year's salary, to be paid to the Widow of the late Lieutenant Colonel *Donald Macdonald*, Deputy Adjutant General for *Upper Canada*, and this House pledges itself to make good the same.

*Ordered*, That the said Addresses be presented to His Excellency the Governor General, by such Members of this House as are of the Honorable the Executive Council of this Province.

The House, according to Order, proceeded to take into further consideration the remaining Resolutions which were, this day, reported from Committee of Supply.

And the Seventeenth Resolution, being read a second time, and the Question being put, That this House doth concur with the Committee in the said Resolution; the House divided:—And it was resolved in the Affirmative.

The Eighteenth Resolution, being read a second time, was agreed to.

The Nineteenth Resolution, being read a second time; and the Question being proposed, That this House doth concur with the Committee in the said Resolution;

The Honorable Mr. *Brown* moved, in amendment, seconded by Mr. *Gibbs*, That all the words after "That" to the end of the Question, be left out, and the words, "the said sum of \$191,904.40 cts., as Seigniorial Indemnity to the Townships of *Lower Canada*, "be not concurred in, the payment of the said Indemnity having been assigned under the "arrangement for the Union of the British North American Provinces, as a liability of the "Local Government of *Lower Canada*, and the Indemnity to *Upper Canada* as a liability "of the Local Government of that Province," inserted instead thereof;
