What are the names and salaries of officials of the civil service who enjoy the rank of deputy minister and who may not be actually in charge of a department, exclusive of those reported in unrevised Hansard, April 17, 1929, page 1720?

Public Archives:

A. G. Doughty, deputy minister, \$9.000.

Auditor General:

The auditor general, Georges Gonthier, \$15,-000 per annum.

Office of the Chief Electoral Officer:

Jules Castonguay, chief electoral officer, salary \$6,000 a year.

Civil Service Commission:

Honourable William James Roche, M.D., LL.D., P.C., chairman, \$7,000; Joseph Emile Tremblay, commissioner, \$6,000; Newton McFaul MacTavish, M.A., D. Litt., commissioner, \$6,000.

Library of Parliament:

There are two joint-librarians, each having the rank of deputy minister; i.e. Hon. Martin Burrell, parliamentary librarian, and M. J. de L. Tache, general librarian. Each receives a salary of \$6,000 per annum.

How many officers of the Canadian Expeditionary Force had their pensions reduced under section (14) subsection (1) of the Pen-sions Act, in each of the years 1921-2-3-4-5-6-7?

IMMIGRATION-R. A. BURRISS

Mr. COWAN:

1. Does the Dominion of Canada own the site of the immigration hall at Port Arthur,

site of the immigration half at Port Arthur, Ontario, and the building thereon, and, if so, what did the site and building cost? 2. When was R. A. Burriss appointed immi-gration officer at Port Arthur; what were the terms of his employment, and is any record available of the number of settlers located by $\frac{1}{2}$. him?

Mr. RINFRET:

1. Title vested in Canadian National Realties Limited.

2. (a) The record of Mr. Burriss's employment at Port Arthur is as follows-February 1, 1899, as agent for the purpose of obtaining settlers from the United States. The terms of his employment were :- February 1, 1898 to March 31, 1899, allowance of \$50 per month for expenses plus a commission of \$3 for every male settler over 18 years, \$2 for every female settler over 18 years, and \$1 for all under 18 years. From April 1, 1899, to October 1, 1899, expense grant of \$100 per month instead of \$50 per month as formerly. August 1, 1900, placed on the salary basis of \$50 per month from the Dominion government and \$50 per month from the Ontario government. No commission. May 1, 1901, owing to withdrawal of Ontario government grant, appointed as temporary agent at salary of \$1,000 per annum and travelling expenses when
