UNEMPLOYMENT RELIEF—SASKATCHEWAN COMMISSION SUPERVISOR

3. What are their duties and when did their employment commence?

4. What salary and expenses or other remuneration have each of them been paid since their appointment?

1. John Strain, Clive Burke, T. J. Graham.

2. Minister of Agriculture.

3. Employment commenced October 1, 1931, as temporary federal supervisors in the province of Saskatchewan in connection with relief disbursed by the Saskatchewan relief commission under the Unemployment and Farm Relief Act, 1931.

4. Salary \$150 per month each. Travelling expenses since appointment, John Strain \$557.65, Clive Burke \$1,468.10 and T. J. Graham \$1,099.65.
