Hon. Judy V. LaMarsh (Secretary of State): I have been given the following information by the Public Service Commission: 1. Yes. In January of this year the Public Service Commission endeavoured to recruit in the United States, professional personnel administrators with specialized training and qualifications in job evaluation and pay administration to fill existing vacancies in several departments of government including the bureau of classification revision.

2. (a) The Public Service Commission was prepared to recruit up to forty eight officers possessing the special qualifications referred to in (1). (b) The duties of officers who might be recruited may be summarized briefly as follows:

For officers placed in departments: the implementation within the department of the current classification program; job
