REJECTION BY UNIONS OF APPEALS FOR MODERATE WAGE DEMANDS

- 1. In its effort to combat the present high inflation cycle in Canada, is it the government's intention to make a special enquiry into the problem of "why unions reject appeals to moderate wage demands"?
- 2. What reason is being given by CLC and CNTU that any program of voluntary restraint on wages will be rejected?

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): 1 and 2. No. The Prices and Incomes Commission has engaged in a series of exploratory discussions with the executives of the CLC and the CNTU, with a view to broadening the restraint program, endorsed by the Federal/Provincial Conference of First Ministers at their meeting on February 16-17, 1970 to include wage and salary earners. This subject was discussed at public meetings between the Government and the CLC and the CNTU on March 23, 1970.
