RELIEF OF REFUGEES FROM EAST PAKISTAN—CANADIAN CONTRIBUTION THROUGH UNITED NATIONS IN LIGHT OF REPORTED BRITISH OFFER

Mr. Andrew Brewin (Greenwood): My question is addressed to the Acting Prime Minister. In light of reports that the United Kingdom is contemplating making a very substantial contribution—I think a figure of one million pounds sterling was mentioned—for the relief of refugees from East Pakistan through the United Nations, is the Canadian government considering or will it consider making a contribution of similar proportion through the same channels?

Hon. Mitchell Sharp (Acting Prime Minister): We are now in receipt of information from the United Nations Commissioner for Refugees concerning the extent of the problem and we are beginning to receive general requests for assistance. This matter is under study and I hope to be in a position to make an announcement very soon.

MASSING OF TROOPS ON INDIA-PAKISTAN BORDER— CANADIAN ACTION THROUGH UNITED NATIONS TO AVERT CONFLICT

Mr. Andrew Brewin (Greenwood): In view of the fact that there has been a massing of troops on both sides of the border between India and Pakistan and bearing in mind the explosive situation which exists there, will the Canadian government invoke the good offices of the United Nations to seek a mutual withdrawal which would minimize the danger of conflict in that area?

Hon. Mitchell Sharp (Acting Prime Minister): I do not know whether that would be the most effective means of achieving a purpose, with which we all agree, but we are doing everything we can to avoid an exacerbation of the situation and to avoid a conflict which I agree with the hon. member would be a most tragic affair.
