REQUEST FOR STATEMENT OF POLICY ON WORK PERMITS FOR STUDENTS

Will the minister, in his statement, ensure that he makes it clear that students will be given an opportunity through work permits in the summer to carry on their education?

REPORTED COURT DECISION GRANTING NATIVE BROTHERHOOD PERMISSION TO FILE CAVEAT ON MAJOR PORTION OF MACKENZIE VALLEY—GOVERNMENT POSITION

Mr. Erik Nielsen (Yukon): Mr. Speaker, I should like to direct a question to the Minister of Indian Affairs and Northern Development based on press reports of a decision of Mr. Justice Morrow of the Supreme Court of the Northwest Territories granting permission to file a caveat on behalf of the Native Brotherhood of the territories over a major portion of the whole of the Mackenzie valley. Does the government intend to take any action with respect to that decision, if it is reported accurately, and, if so, what action?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): Mr. Speaker, in my opinion the hon. member did not quite understand the newspapers. The judge has taken the case under consideration and did not render any final decision. He has authorized the parties to prepare their case and a hearing will take place on May 15. As can be expected, I think the federal government and the territorial government will make representations as will the Indians.
