PROGRAM OUTLINED IN SPEECH FROM THE THRONE—MOTION UNDER S.O. 43

In the Speech from the Throne delivered on April 14, 1980, when the mortgage interest rate was 16 per cent, the government said it would assist those unable to bear the burden of renegotiating home mortgages, but later cancelled the alleged program of assistance because the interest rate decreased. I move, seconded by the hon. member for Vancouver Quadra (Mr. Clarke):

That this House direct the government to keep its promise made in the Speech from the Throne to assist those Canadians who cannot afford the home mortgage interest rate which today exceeds 16 per cent in most of Canada by providing the promised program of assistance.

Notwithstanding the government's promise of April 14, 1980, in the Speech from the Throne, to provide employment opportunities for handicapped Canadians and to add new legislative protections to the Human Rights Act, the government vacillated on entrenching the rights of handicapped persons and said the status of handicapped persons could not be defined. That this House condemns the government for failing to fulfil its promise to handicapped Canadians to introduce legislation amending the Human Rights Act to protect the rights of the handicapped in addition to any recognition granted by a charter of rights.
