opposed to imposing a tax-back scheme on the pensions of the elderly. Is that the position of the Minister of Finance?

Hon. Michael Wilson (Minister of Finance): Mr. Speaker, let me make it quite clear to Members opposite—

Some Hon. Members: Please.

Mr. Wilson (Etobicoke Centre): —that we intend to set out in a very clear way, in papers that will be issued early in the new year, the various options available to us in a limited way. We then want to have an open discussion on these various options to see how we can fulfil the principle that the Prime Minister has just established, that we want to see whether there are ways of maintaining the universality of the programs and direct a greater degree of benefit to those who need it most in our society.

POSSIBLE OPTIONS

Mr. Ian Deans (Hamilton Mountain): Mr. Speaker, would the Minister then inform the House whether one of the options that will be considered is that of taxing back the benefits received by old age pensioners in certain income categories, in direct opposition to the position put forward by the Prime Minister yesterday?

Hon. Michael Wilson (Minister of Finance): Mr. Speaker, patience is a virtue. The papers will be available early in the new year. I think that if Hon. Members opposite would cease trying to cast fear into the hearts of the people who need help most, and let us get on with the debate we have said is important, it will happen in due course, and I hope that Hon. Members participate fully in that debate.

UNEMPLOYMENT INSURANCE

REQUEST FOR MINISTERIAL ASSURANCE

Hon. Flora MacDonald (Minister of Employment and Immigration): Mr. Speaker, I am not sure where the Hon. Member has been gathering his information. Certainly not through consultations with me, I can assure you, Sir. I have no intention of making any statement or undertakings by Orderin-Council during the Christmas recess.

Mr. Crosbie: So is he.

Miss MacDonald: There is no document. Perhaps if he would like to speak to me privately to explain what it is he is getting at, we might be able to satisfy his request. I can assure you, Sir, that there is no document that I have yet had a chance to prepare.

MINISTER'S STATEMENT

Hon. Michael Wilson (Minister of Finance): Mr. Speaker, what the Hon. Member is trying to do is prejudge the whole consultation process that Canadians want to participate in. I say to her, as I said to her colleague, be patient. The papers will be out shortly and then—

Ms. Mitchell: People are worried. Old age pensioners are worried.

Mr. Wilson (Etobicoke Centre): —we want to have a full discussion. She says the old age pensioners are worried. They have no reason to be worried, and they would not be worried except for the canards the Hon. Member throws up to cast fear into their minds. There is no reason.
