AUTHORIZATION FOR COMMITTEE TO TRAVEL

Mr. Albert Cooper (Parliamentary Secretary to Minister of State and Leader of the Government in the House of Commons): Mr. Speaker, I believe that you will find consent to place the following motion without debate or amendment. I move:
