Order in Council, P.C. 2476, dated 28th November, 1933: authorizing payment to the Province of Alberta of the sum of \$2.40 for direct relief in unorganized districts-Improvement District No. 603.

Order in Council, P.C. 2520, dated 6th December, 1933: authorizing payment to the Province of Quebec of the sum of \$917.81 for municipal works in

the Town of Beauport, Quebec County.

Order in Council, P.C. 2625, dated 20th December, 1933: authorizing payment to the Province of Saskatchewan of the sum of \$7.50 for provincial

works-placement of unemployed persons on farms.

Order in Council, P.C. 2702, dated 28th December, 1933: authorizing payment to the Province of New Brunswick of the sum of \$140.88 for municipal direct relief.

Mr. Gordon, a Member of the King's Privy Council, laid before the House, by command of His Excellency the Governor General,-Annual Report of the Department of Labour for the fiscal year ending March 31, 1933, which includes reports of proceedings under the following statutes: Labour Department Act, Conciliation and Labour Act, Fair Wages and Eight Hour Day Act, Industrial Disputes Investigation Act, Government Annuities Act, Employment Offices Co-ordination Act, Technical Education Act, Combines Investigation Act, Old Age Pensions Act, and Unemployment Relief Measures.

He also presented,—Return to an Order of the House of the 24th May, 1933, for a copy of all correspondence, evidence, reports, and other papers and documents respecting the investigation recently held regarding the administration of relief funds at Glace Bay, Nova Scotia.

Also,—Return to an Order of the House of the 27th February, 1933, for a copy of all letters, telegrams, requests, or other correspondence received since July, 1931, by the Government, or any of the ministry or officials, respecting the investigations held in connection with unemployment relief work carried out in Lake St. John county.

And also laid before the House, -Copies of Orders in Council passed under

the provisions of the Relief Act, 1933, as follows:-
