Whereupon the Honorable Mr. Murphy came to the Table and took and subscribed the oath prescribed by law, which was administered by Edouard Joseph Langevin, Esquire, one of the Commissioners appointed for that purpose, and took his seat accordingly.

The Honorable the Speaker then acquainted the House that the Clerk of the Senate had laid upon the Table the Certificate of one of the Commissioners setting forth that the Honorable Mr. Murphy, a Member of the Senate, had made and subscribed the Declaration of Qualification required by the British North America Act, 1867.
