Order Paper Questions DND GARBAGE REMOVAL AND DISPOSAL CONTRACT OTT76/24969/1

Question No. 2,275—Mr. McKinnon:

Is the cost of DND garbage removal and disposal contract, OTT76/24969/1 for the sum of \$486,619, let to Charette's General Trucking of Petawawa, Ontario, over ten times the average of four other garbage contracts published in the Weekly Bulletin of Business Opportunities Volume 4, Number 9 and, if so, for what reason?

Hon. Jean-Pierre Goyer (Minister of Supply and Services): No. The contract OTT76/24969/1 is for a period of four years while the other contracts listed are for one or two years. The five contracts are not comparable in terms of the number of pick-up points, frequency of pick-ups, population at the bases or stations and type of service, i.e. containerized vs compacter trucks.

GRANT TO BÉLANGER-TAPPEN COMPANY FOR CONSTRUCTION OF PLANT AT ST. BRUNO, COUNTY OF CHAMBLY

Question No. 2,293—Mr. Lambert (Bellechasse):

Did Bélanger-Tappen Company request a grant for the construction of a refrigerator plant at St-Bruno, County of Chambly and, if so, has any decision been taken by DREE?

Mr. Ed. Lumley (Parliamentary Secretary to Minister of Regional Economic Expansion): The reply for the Department of Regional Economic Expansion is as follows: No. The County of Chambly is not located within the designated area of Quebec under the Regional Development Incentives Act.

Mr. Clarke: I rise on a point of order, Mr. Speaker. ALLOTTED DAY S.O. 58—ALLEGED FAILURE OF GOVERNMENT TO IMPROVE EMPLOYMENT SITUATION

Mr. David MacDonald (Egmont) moved:

That in the opinion of this House, the government's abandonment of its commitment to develop strong regional economies and its failure to give priority to regional needs in designing national fiscal, transport, energy and trade policies has resulted in a crisis of economic stagnation and unprecedented unemployment in Quebec and the Atlantic provinces.

He said: Mr. Speaker, there has been such day to day concern about the basic fabric and future of this country among Canadians that those who live outside the five eastern provinces tend to overlook the existence of a deepening and widening crisis with respect to the lives and, indeed, the possibilities open to those who live in Atlantic Canada and Quebec. This debate is about Quebec and the Atlantic provinces, presently in the grip of record unemployment and economic stagnation, two regions which would not be in such a position today had the government gone even halfway toward living up to its promise of the late sixties to eradicate regional economic and social disparities.

This debate is about regional development. It is not about the Department of Regional Economic Expansion because the indifferent record of DREE in implementing lasting solutions to what the Economic Council of Canada has described as intolerable levels of disparity across Canada is only one aspect of the government's sad abandonment of this country's havenot regions and their aspirations. This debate is about the indifference, callousness, insensitivity and forgetfulness shown with regard to the legitimate economic needs of Quebec and
